**Purpose of This Form.** Form RPD-41384, *Notice of Transfer of New Sustainable Building Tax Credit*, must be used to report to the Taxation and Revenue Department (TRD) a transfer of approved new sustainable building tax credit. Before using this notice to report a transfer, the current holder must have a TRD-approved Form RPD-41382, *New Sustainable Building Tax Credit Approval*, or a TRD-approved Form RPD-41384, *Notice of Transfer of New Sustainable Building Tax Credit.* 

Form RPD-41384 may be used by a TRD-approved holder who sells, exchanges or transfers their credit to another taxpayer, or by a holder, other than the original building owner, who is a partnership or other business association passing the credit to its members, partners, shareholders, or beneficiaries.

Both the holder and the new holder, or their authorized representatives must sign and date this notice. This signed notice must be mailed within 10 days of a sale, exchange, or other transfer to: New Mexico Taxation and Revenue Department, Edit Error, PO Box 5418, Santa Fe NM 87502-5418.
