RE: Request to Transfer the Banner Mill Reclamation Permit HI001RE

Mr. Fernandez:

Pyramid Peak Mining, LLC hereby requests the transfer of the Permit HI001RE for Banner Mill previously operated by the Lordsburg Mining Company of 11289 Pennsylvania NE, Suite 200, Albuquerque, NM 87110. Per New Mexico Administrative Code (NMAC) 19.10.8.802 Permit Transfer Rules, the following information is being provided to fulfill section A(1) through A.(4).

### (1) Obtain financial assurance coverage as required by 19.10.12 NMAC for the permit area;

Surety bond No. 1143789 in the amount of \$25,244.87 and bond No. 1143790 in the amount of \$206,471.00 have been received by the New Mexico Energy, Minerals and Natural Resources Department Mining & Minerals Division as of October 11, 2016 to cover reclamation costs.
