Dear Mr. Shelley:

The New Mexico Mining and Minerals Division ("MMD") and the New Mexico Environment Department ("NMED") received a submittal from Freeport-McMoRan Copper & Gold, Tyrone Operations ("Tyrone"), entitled, "Tyrone Mine Financial Assurance Reduction Request for Modification of Permit No. GR010RE, Revision 01-1", ("Application"), dated December 17, 2012. The Application requested a release of financial assurance ("F.A.") for the reclamation work completed at the No. 1C/7A stockpile unit at the Tyrone Mine and for completion of the Additional Studies required by MMD Permit No. GR010RE, Revision 01-1, and NMED Discharge Permit DP-1341.

MMD reviewed the Application, and is processing it as Modification 12-3 to Permit No. GR010RE. NMED is processing the Application as an amendment to DP-1341. MMD sent Tyrone comment letters on the Application dated March 26, 2013 and May 20, 2013. Tyrone responded to the MMD comments in a letter to MMD, dated July 10, 2013. In that letter, Tyrone has revised the request for F.A. release from \$5,983,278 (2003 dollars) or \$5,426,777 (net present value, "NPV") to \$5,914,182 (2003 dollars) or \$5,364,107 (NPV) for the reclamation work completed at the No. 1C/7A stockpile. In addition, Tyrone has revised the request for F.A. release from \$2,263,170 to \$1,933,170 for the Additional Studies required by Permit No. GR010RE, Revision 01-1 and DP-1341 that have been completed as of December 31, 2012.

MMD and NMED have reviewed the July 10, 2013 letter from Tyrone and concur with the changes to the Application that Tyrone has proposed. MMD hereby deems the Application technically approvable. MMD and NMED hereby require that Tyrone submit a revised F.A. proposal to MMD and NMED within 30-days of receipt of this letter. The revised F.A. proposal shall include a Certificate of Face Amount Adjustment to the Third Party Guarantee. The amount of the Certificate of Face Amount Adjustment to the Third Party Guarantee the Third Party Guarantee by \$7,847,352 (2003 dollars) or \$7,297,277 (NPV) The total Third Party Guarantee shall be reduced from \$98,827,127 (NPV) to \$91,529,850 (NPV). When MMD approves Modification 12-3 and NMED amends DP-1341, the total

amount of financial assurance required for the closure/closeout plan of the Tyrone Mine shall be \$178,262,354 (NPV) plus \$170,874 for the Copper Mountain South Pit Expansion.
