COAL SURFACE MINING COMMISSION

OPEN MEETINGS RESOLUTION

WHEREAS, the Coal Surface Mining Commission (the "Commission") met in regular session on July 29, 1994, as required by law; and

WHEREAS, Section 10-15-1(B) of the Open Meetings Act (NMSA 1978, Sections 10-15-1 to -4) states that, except as may be otherwise provided in the Constitution or the provisions of the Open Meetings Act, all meetings of a quorum of members of any board, council, commission, administrative adjudicatory body or other policymaking body of any state or local public agency held for the purpose of formulating public policy, discussing public business or for the purpose of taking any action within the authority of or the delegated authority of such body, are declared to be public meetings open to the public at all times; and

WHEREAS, any meetings subject to the Open Meetings Act at which the discussion or adoption of any proposed resolution, rule, regulation or formal action occurs shall be held only after reasonable notice to the public; and

WHEREAS, Section 10-15-1(D) of the Open Meetings Act requires the Board to determine annually what constitutes reasonable notice of its public meetings;

NOW, THEREFORE BE IT RESOLVED by the Commission that:

Regular Meetings.

- a. Regular meetings of the Commission may be called by the Chairman or by a majority of members upon ten (10) days notice.
- b. The notice requirements are met if notice of the date, time, place and general subject matter to be discussed is placed in newspapers of general circulation in the State. The Commission Secretary shall also mail copies of the written notice to those broadcast stations, newspapers and other persons who have made a written request for notice of Commission meetings.
- c. The notice shall indicate where the public may obtain a copy of the proposed agenda. A proposed agenda will be available during the week before the meeting from the Commission Secretary at the offices of the Energy, Minerals and Natural Resources Department in Santa Fe, New Mexico. Items requiring Commission action may be added to the agenda up to 24 hours prior to the meeting.

2. Special and Emergency Meetings.

- a. Special meetings of the Commission may be called by the Chairman or a majority of the members upon three (3) days notice.
- b. Emergency meetings will be called only under unforeseen circumstances which demand immediate action by the Commission to protect the health, safety and property of citizens or to protect the Commission from substantial financial loss. The Commission will avoid emergency meetings whenever possible. Emergency meetings may be called by the Chairman upon twenty-four (24) hours notice unless threat of personal injury or property damage require less notice.
- c. Notice requirements for special and emergency meetings shall be met by posting notices in the main offices of the agencies represented on the Commission and by delivering copies of the notice to the press boxes located at the Governor's office. The Commission Secretary shall provide telephonic notice to those broadcast stations and newspapers of general circulation that have made a written request for notice of Commission meetings. Special and emergency meeting notices shall list the date, time, place and agenda for the meeting.
- 3. <u>Contact Person</u>. All notices of meetings shall provide the name of a contact person and a phone number for use by an individual with a disability who needs a reader, amplifier, qualified sign language interpreter, and any other form of auxilliary aid or service to attend or participate in the meeting or who needs public documents, including the agenda and minutes, to be provided in an accessible format.

4. Closed Meetings.

- a. The Commission may close a meeting to the public if the subject matter of such discussion or action is exempt from the open meetings requirement under Section 10-15-1(H) of the Open Meetings Act. If the Commission intends to close a meeting, such closure:
- (1) if made in an open meeting, shall be approved by a majority vote of a quorum of the Commission taken during the open meeting. The authority for the closure and the subjects to be discussed shall be stated with reasonable specificity in the motion for closure and the vote on closure of each individual member shall be recorded in the minutes. Only those subjects specified in the motion may be discussed in a closed meeting.
- (2) if called for when the Commission is not in an open meeting, the closed meeting shall not be held until public notice, appropriate under the circumstances and stating the specific provision of law authorizing the closed meeting and the subject to be discussed is given to the members and to the general public.
