It is MMD's understanding that the property is under new ownership. The operator must submit a modification changing the permit to the new ownership.

INSPECTION NARRATIVE:

We traveled to the site with USFS personnel and met the operator's representative, Randy Bouldin, and the operator's consultant, Tim Leftwitch, at the shop location. We arrived on site at approximately 9:30 AM. The shop/maintenance area is about two acres in size. The mine area has not been operated for quite some time. The equipment appears to be deteriorating and will need to be repaired before that mine can operate again.

The pit for this site is 5.86 acres in size and is located immediately east of the shop. The site was still not in operation at the time of this site inspection. MMD had been made aware by local citizens and by the USFS of possible drilling operations outside of the mine's permit area.

The previous mine inspection noted that the operator was conducting a drilling operation. This drilling operation was located outside of the permitted disturbance but still within the overall permit boundaries.

During discussion at the plant site, the operator representative, Randy Bouldin, stated that drilling had taken place on USFS property, outside the permitted disturbance area. We then inspected the drilling areas. It was determined by inspectors with the Mining and Minerals Division, that El Capitan Ltd was operating an exploration operation north of Capitan without an approved permit. Two roads, measuring approximately 800 feet, and at least three holes, had been drilled within an area of about 3 acres, located on the Capitan USGS quadrangle, at GPS 448985,3720086; 449009,3720170; and 448868,3719967. Randy Bouldin, representing El Capitan Ltd., accompanied the inspectors and stated to the MMD inspectors and USFS personnel present, that the drilling had been conducted by El Capitan Ltd., and that it had been conducted without a permit.

Two holes were drilled approximately ½ mile from the mine permit boundary. A road was constructed to access the drilling area. Rock and debris from the construction of the road was placed in an existing arroyo next to the drill sites. Drill cuttings were also placed in the arroyo. See photos below.

PERMIT UPDATE:

The Capitan Iron Mine is permitted, however, the operator just recently engaged in unpermitted exploration activity in areas adjacent to the mine. The operator was given a violation and has been involved in mitigation efforts since. The operator has reclaimed the exploration disturbance and cleaned debris, machinery and chemicals from the site.

INSPECTION NARRATIVE:

- Participants: El Capitan Resources LLC: Steve Boloch, Randy Bouldin; GL Environmental: Denise Gallegos, Mathew Lane; USFS: Richard Carlson, Buck Sanchez, Christina Humphrey
- Purpose of Inspection: review the reclamation/mitigation measures being taken to address unpermitted activity. My first visit to the site.
- MMD has written a cessation order in May to stop un-permitted exploration activities
- This inspection was performed to follow-up on the CO and the status of the site
- We met at the El Capitan Iron Mine site, at the shop building. The exploration activity took place in and around the existing mine site. The El Capitan Mine is a permitted minimal impact mining operation.
- I met first with Steve Boloch and Denise Gallegos. They explained that they had been working on reclaiming the exploration disturbance and cleaning up the mine site.
- Three truck loads of debris had been hauled out of the site. Oil and chemicals have been removed by a contractor titled REMCO. Hazardous materials were taken to a licensed facility (incinerator in Colorado) for disposal. Denise is to send me a manifest listing all hazardous chemicals.
- GL Environmental hired Rocky Mountain Reclamation to perform the reclamation of staging areas, roads, and pads related to the exploration activity. This is the same contractor being employed by PD to reclamation the Tyrone mine. Mathew Lane has been overseeing this activity.
- The operator has reclaimed approximately 18 un-permitted exploration holes and associated roads, all on USFS property. The holes and associated roads have been constructed in areas south, east, west and north of the Capitan Mine site (see attached map provided by the operator).
- Seeding took place three weeks ago.
- The operator has been working cleaning up the site for 3 months.
- All roads, pads, and staging areas have been ripped/scarified, seeded and mulched.
- Areas around the mine buildings have been cleaned up, trash and debris removed, and the area has been reclaimed.
- There have been citizen complaints related to the draw that empties out from the mine. We followed the draw for awhile and saw some debris, but nothing consisting or oil and batteries indicated by the citizens. This material may have been further downstream.

- Some of the trash, debris, oil cans, etc. may have been left by older operations.
- Staff from the USFS Capitan District also attended the inspection. The USFS has been dealing with citizen's complaints and also is taking enforcement action against the operations for un-permitted exploration activity.
- Buck Sanchez indicated that the USFS had recently had a public meeting in Capitan
 with concerned citizens. They had complained about the debris and alleged hazardous
 materials in the draw and at the mine and asked the USFS to look into it. Buck asked if
 the state could investigate, and I indicated yes, also that I would ask the NMED to look
 into it, and in fact, already had alerted them.
- The operator is proposing a 133 hole exploration project at the site. This will include new roads and pads. The USFS has told ECR that there will be a NEPA process and that this will involve a Plan of Operations and an EA. The USFS also indicated that the process will take sometime because of the public scrutiny and the steps required for an EA.
- The Plan of Operations has not been officially submitted yet. The operator is still
 working out details with the USFS regarding its content.
- The operator indicated that they may request 133 holes, but not ever drill this many.
- ECR owns 40% of the company and Gold and Minerals 60%. Ken Pavlich is the CEO of ECR.
- Mine equipment from the mine has been moved off to a mine and mill in Arizona.
- The only materials, of a processed nature, left at the site are bags and barrels of concentrate (ore grade material) that is all being stored in the mine shed.
- All steps are completed for abatement of the violation except providing the USFS and MMD with a copy of the ownership survey.
- The operator has almost completed reclamation of the disturbed exploration area. Minor elements remain. I asked Mathew to address the mounds of debris still around the drill holes. These would need to knocked down, covered and seeded. Additionally, some road disturbance on private property would need to be reclaimed.
- I told Denise and Steve that the violation could not be abated until I received a copy of the survey, asked for in the violation. Once received I will send a letter indicating the violation has been abated.
- The USFS pointed a couple areas where the operator should remove noxious weeds: Musk Thistle and Tamarisk.
- The USFS asked that the operator pull back material deposited into washes from exploration pad development.
- The USFS is still working on their enforcement action.
- I contacted NMED concerning the USFS request for assistance concerning potential issues related to dumping. Buck Sanchez indicated he would be sending me a request letter.
- Remaining steps for MMD: send abatement completion letter, approve abatement plan, permit transfer needed, address citizen complaints regarding dumping. There is no exploration application to process at this time.

ACTION ITEMS:

- Letter to operator recognizing abate of the violation
- Approval document to operator approving the reclamation plan for the exploration cleanup.

- The USFS has requested help investigating complaints from the locals that the operator has been dumping illegally at the mine site.
- The operator needs to provide MMD with a permit transfer.
