PERMIT UPDATE:

INSPECTION NARRATIVE:

I met with Clint Anderson at the junction of Byers run and South Fork drainages. Clint had informed me that the road through Byers run was washed out and not readily accessible to most vehicles. The road going up to the mine also was covered in ice from water in Byers run. Clint drove us up in a four-wheeler.

Clint informed me that he is working on purchasing the Midnight Mine at this time. I informed him of the transfer fee and also the amount of the annual fees. No new disturbance was noted at the site from the last inspection. The two RV 5th wheels are still there. No evidence of mining was noted (equipment, fresh stockpile material).
