Dear Director (Mr. Martinez):

I would like to request a public hearing per the certified letter, received in early October 2014.

As a property owner in Fierro, there are some concerns that come to my attention. After reviewing the attachments (maps of the proposed road) to the letter the major concerns are the following:

- 1. Will the haul road affect the Church in Fierro at all, to include:
 - a. Access via Fierro Road.
 - b. Construction vicinity the church that will cause structural damage
 - c. Noise of trucks hauling ore that will disrupt mass services, Mass is held in Fierro every other Saturday.
- 2. Does the haul road affect the Fierro cemetery in any way
- Figure A5 indicates that crossing over forest service access road and Hanover Creek will be demolished. After the haul road is complete will there be access to the U.S. Forest Service via Fierro Road and more importantly to the Water Spring.
- 4. In an earlier article by the Cobre Mining Co. "Preparations are Beginning for Mining to Resume at Cobre Mining Co.", dated November 2011, a question was answered on the widening of Fierro Road, stating "Once a new haul road is in place for the haulage of ore from Cobre, it can also be used for other mine-related traffic", Does this mean that Cobre Mining employees will use the haul road to get to work, and if so will the Fierro Road still be maintained, or will property owners be allowed to also use the haul road.
- 5. Once the haul road is finished are there any plans in the future to connect the haul road to other existing roads from the mine, for example the current road that runs alone, Poison Spring Drainage?
