The New Mexico Mining and Minerals Division (“MMD”) received a letter from Rio Grande Resources Corporation (“RGR”), dated October 1, 2014, requesting renewal of standby status for the Mt. Taylor. MMD has assigned Revision 14-1 to Permit No. CI002RE to process the application to renew standby status. MMD reviewed the application to renew standby status and deemed it administratively complete on December 5, 2014. Subsequently, MMD sent a copy of the application to renew standby status to other state agencies and tribal entities requesting their comments pursuant to 19.10.5.505.B(3) and 19.10.506.E NMAC. MMD has received responses from the New Mexico Environment Department (“NMED”), the New Mexico Office of the State Engineer (“NMOSE”), the New Mexico Department of Cultural Affairs (“NMDCA”), the New Mexico State Forestry Division (“NMSFD”); and the Navajo Nation.

MMD is enclosing copies of the response letters and e-mails from the NMED, NMOSE, NMDCA, the NMSFD and the Navajo Nation for RGR’s review and response. Please respond to these comments within 30 days of receipt of this letter. MMD will provide comments on the application to renew standby status under separate cover.



The New Mexico Environment Department (NMED) received a request, dated December 5, 2014, from the New Mexico Mining and Minerals Division (MMD) to review and provide comments on the above-referenced Application, dated October 12, 2014, to renew standby status for the Mt. Taylor mine. The Mt. Taylor mine, which is owned and operated by Rio Grande Resources Corporation (RGRC), is a conventional underground uranium mine that is located approximately one-half mile northeast of the Village of San Mateo in Cibola County, New Mexico, in Section 24, Township 13 North, Range 8 West.

The application and recent site inspection by NMED personnel indicate that no changes in the physical conditions of the site have occurred since the last renewal of standby. Review of the application to renew standby indicate there are no proposed changes from the previous standby approval. The Ground Water Quality Bureau, Surface Water Quality Bureau, and Air Quality Bureau have no comments on the current application to renew standby. NMED previously issued a determination dated May 27, 2011 that environmental standards will be met during the standby period if carried out as described in the New Mexico Mining Act permit application. The previous determination by NMED still stands.

On December 2, 2014, the New Mexico Office of the State Engineer Hydrology Bureau (NMOSE) received a request for review and comments from the Mining and Minerals Division (MMD) for the Revision 14-1 to renew standby status for the Mt. Taylor Mine – Rio Grande Resources Corporation – MMD Permit No. CI002RE (Revision). Mt. Taylor Mine is located in Section 24, T13N, R8W near the village of San Mateo in Cibola County. NMOSE has reviewed the materials for this Revision, which requests renewal of standby by adding a 5-year term thru October 12, 2019 or when mine returns to active status. Previously, NMOSE has commented six times on three CI002RE revisions numbered 10-1 (OSE comments August 4, 2010), 13-1 (OSE comments April 11, 2013 & February 13, 2014) and 13-2 (OSE comments March 7, 2014; June 9, 2014 & August 20, 2014). The previous revisions include an updated closure/closeout plan, a renewal of standby status for two years (thru October 12, 2014) and a change from standby to active status.

NMOSE has no comments for this Revision.

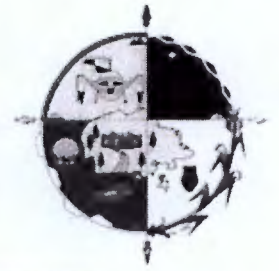

The Historic Preservation Department-Traditional Culture Program, hereafter (HPD-TCP) is in receipt of your letter regarding the proposed permit renewal for the Mount Taylor Mine located in Cibola County, New Mexico.

After reviewing the information documents provided, HPD-TCP has determined the project **will have** adverse effects to Navajo Traditional Cultural Properties. HPD-TCP on behalf of the Navajo Nation has concerns at this time. Mt. Taylor's criteria stands as registered as a National Historic Site on the Register for Historic Places, therefore the Navajo Nation opposes the application from Rio Grande Resources Corporation to renew standby status for the Mount Taylor Mine. This property stands as a sacred site according to Navajo traditional cosmology and worldview, along with many other indigenous nations in the greater southwest. HPD-TCP urges the New Mexico Mining and Minerals Division to withdraw the permit request and cease mining activity on Mount Taylor. *(The Navajo Nation claims cultural affiliation to all Anasazi people (periods from Archaic to Pueblo IV) of the southwest. The Navajo Nation makes this claim through Navajo oral history and ceremonial history, which has been documented as early as 1880 and taught from generation to generations).*
