## Legal Notice

### Permit Application Package for Revision 17-2 to Permit No. GR009RE, Chino Mine

Pursuant to the New Mexico Mining Act Rules, 19.10.5 and 19.10.9.903.A through H., Freeport-McMoRan Chino Mines Company (Chino) provides this notice of its application to the New Mexico Energy, Minerals and Natural Resources Department Mining and Minerals Division (MMD) for a revision of permit GR009RE (Permit). Chino proposes to revise this Permit to increase its approved design limit boundary to facilitate the construction of the 9 Waste Rock Stockpile (9WRS) and associated facilities. The expansion will be addressed under NMAC 19.10.5.507 and 508 Existing and New Unit Expansions. Pursuant to NMAC 19.10.5.506, 507 and 508 and Section 8 of Permit GR009RE, a mining operation and reclamation plan for this stockpile has been included with the permit application package.

Location of real property affected: Chino is located approximately 15 miles east of Silver City in Grant County, New Mexico. The proposed 9WRS and auxiliary facilities will be located within Section 2, Township 18 South, Range 12 West, and Section 3, Township 18 South, Range 12 West, within the Santa Rita Mine 7.5 min Quadrangle.

General description of the operation and proposed changes: Chino is an existing mining operation producing copper cathodes and copper concentrate. The proposed changes will expand the Chino design limit boundary by approximately 248 acres to allow for the construction of the 9WRS and associated infrastructure. The proposed stockpile will be located in the southeastern portion of the mine where Reservoir 9 is currently located. The stockpile will be buttressed by hillsides with the exception of the north side, which will be buttressed by an existing haul road.

De conformidad con el Reglamento de la Ley de Minería de Nuevo México, 19.10.5 y 19.10.9.903. A través de H., Freeport-McMoRan Chino Mines Company (Chino) se proporciona esta notificación de solicitud a la División de Minería y Minerales del Departamento de Energía, Minerales y Recursos Naturales de Nuevo México (MMD, por sus siglas en inglés) para una revisión del permiso GR009RE (Permiso). Chino propone revisar este Permiso para incrementar su demarcación de límites de diseño aprobado, para facilitar la construcción del Acopio de Roca Residual 9 (9WRS, por sus siglas en inglés) y las instalaciones asociadas. La expansión se tratará bajo NMAC 19.10.5.507 y Expansiones Existentes y Nuevas Unidades 508. De acuerdo con NMAC 19.10.5.506, 507 y 508 y la Sección 8 del Permiso GR009RE, se ha incluido una operación de minería y un plan de recuperación para esta reserva en el paquete de solicitud del permiso.

Ubicación de la propiedad inmobiliaria afectada: Chino está ubicada a aproximadamente 15 millas (24 Kilómetros) al este de Silver City en el condado de Grant, Nuevo México. El 9WRS propuesto y las instalaciones auxiliares estarán localizados dentro de la Sección 2, Municipio 18 Sur, Rango 12 Oeste, y Sección 3, Municipio 18 Sur, Rango 12 Oeste, dentro del Cuadrángulo 7,5 min de la Mina Santa Rita.

Descripción general de la operación y cambios propuestos: Chino es una existente operación minera que produce cátodos de cobre y concentrado de cobre. Los cambios propuestos ampliarán la demarcación de los límites de diseño de Chino en aproximadamente 248 acres (1 Km<sup>2</sup>) para permitir la construcción del 9WRS y la infraestructura asociada. El acopio propuesto estará ubicado en la porción sureste de la mina donde actualmente se encuentra el Reservorio 9. El acopio estará contenido por laderas con la excepción del lado norte, que será contenido por una carretera de acarreo existente.

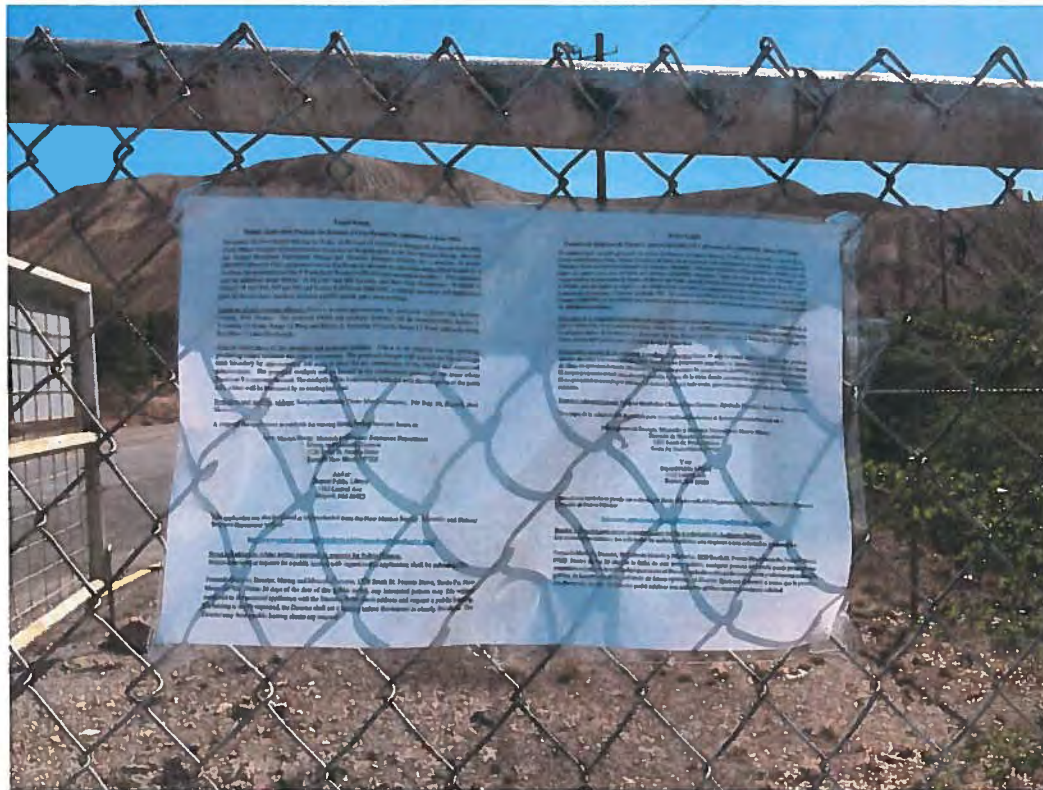
