## PERMIT MODIFICATION 19-1 TO PERMIT NO. MK007ME STAR LAKE MINE – MESA VERDE HUMATES, LLC MINIMAL IMPACT EXISTING MINING OPERATION

This Modification 19-1 ("Modification 19-1") to Permit No. MK007ME ("Permit") is issued by the Director of the Mining and Minerals Division ("MMD") of the New Mexico Energy, Minerals and Natural Resources Department to:

("Permittee") for the Star Lake Mine - Mesa Verde Humates, located in McKinley County, New Mexico.

#### This Modification 19-1:

- 1. Approves the release of 8.9 acres as being reclaimed, except for revegetation; and
- 2. Holds a total of \$64,044.00 of financial assurance ("FA") for revegetation of 60.3 acres of reclamation and ten (10) acres of future disturbance at this site by the Permittee. The table in Appendix 1 on page 6 of this modification summarizes the FA required and held by MMD for this project.

In order to accomplish the approval contemplated by this Modification 19-1, the following subparagraphs are added to Permit No. MK007ME:

#### Section 1 (19-1). STATUTES AND REGULATIONS

- A. This Permit modification is issued pursuant to the New Mexico Mining Act, NMSA 1978, §69-36-1, et seq. (1993, as amended through 2019) ("Act") and New Mexico Mining Act Rules, Title 19, Chapter 10 of the New Mexico Administrative Code ("NMAC" or "Rules" or "Regulations").
- B. This Permit modification is subject to the Act, the Rules, and any other regulations which are now or hereafter in force under the Act; and all such regulations area made a part of this Permit by this reference.

## Section 2 (19-1). PERMIT APPLICATION PACKAGE

- A. The permit application package for Modification 19-1 ("19-1 PMP") consists of a written request from the Permittee, dated May 28, 2019, for the release of 8.9 acres, and includes a map of the reclaimed area and a brief description of the reclamation work performed.
- B. On June 5, 2019, an addendum to 19-1 PMP was submitted by electronic mail messaging indicating that Permittee had completed re-seeding of the 8.9 acres using 8 lbs. of PLS per acre of Triticale in addition to the Chaco Blend seed mix.
- C. Certificate of deposit number 1210416727, in the amount of \$817.00, issued by First American Bank, 4301 The 25 Way NE, Albuquerque, NM on September 6, 2019.

#### Section 3 (19-1). FINDINGS OF FACT

- A. The Permittee has paid the permit modification fee of \$250.00 as required by §19.10.2.201 of the Rules.
- B. The application for permit modification has been reviewed in accordance with §19.10.5.505 of the Rules. The application for permit modification is complete, accurate, and complies with the requirements for permit modifications under §19.10.5.505 of the Rules.
- C. Pursuant to §19.10.5.505.B of the Rules, the proposed change does not require public notice nor the opportunity for public hearing.
- D. Pursuant to §19.10.5.505.B(1) of the Rules, the proposed changes would not have a significant environmental impact.
- E. Pursuant to §19.10.5.505.B(2) of the Rules, the application for permit modification was accompanied by sufficient information for the Director to determine whether any of the factors listed in §19.10.5.505 NMAC are present.
- F. The Director has provided notice of this application to other government agencies deemed appropriate, in accordance with §19.10.5.505.B(3) NMAC.
- G. An inspection and evaluation of the 8.9 acres requested for release was conducted by MMD and New Mexico Department of Game & Fish personnel on June 4, 2019.
- H. The Permittee has provided FA to cover the costs of reclamation as required by §19.10.3.303.K(3) NMAC. The FA was transferred from the release of approximately 8.9 acres, minus \$817.00 for revegetation success, to cover the design limit of ten (10) acres of

future mining disturbances. The financial assurance instruments for the Star Lake Mine – Mesa Verde Humates, Permit No. MK007ME, are in the form of:

- I. FA in the amount of \$64,044.00 is in place and has been determined by MMD to be sufficient to meet the requirements of the Act, Rules, and the Permit.

#### Section 10 (19-1). CONCLUSIONS OF LAW

A. The request for permit modification is complete and accurate and complies with the requirements of the Act and §19.10.3.303 NMAC.

All other provisions, modifications, and revisions for mining and reclamation contained in Permit No. MK007ME, for Star Lake Mine – Mesa Verde Humates, LLC, remain unchanged.
