Carmen,

- 1. On behalf of the permittee, Ray Boseljcic, I am requesting a modification of Permit NO. C1006MN. The reason for the modification is that International Stone, the company named in the permit, no longer exists.
- 2. The company that will be responsible for reclamation will be:

The existing International Stone financial assurance bond for reclamation is being transferred to Stoneworld Company Inc. and will be forwarded to you within 30 days.

- 4. The State and BLM have determined that the Post Mining Land Use ("PMLU") will be changed to recreation.
- 5. Earthwork and Seeding The berms around the outer perimeter of the rock quarry will be recontoured to a more natural grade, per the original permit. The central sloped area be regraded will be a 3:1 slope, reseeded to create a more natural and safe landscape for recreational use.
- 6. The topsoil will be placed in relatively flat areas to be used as the bed for application of plant seeds, especially around the highwall of the quarry. The exact seed mix to be broadcast will be approved by the State MMD prior to application. Certified weed-free mulch will be applied after seeding and crimped in to prevent wind erosion of the seed and disturbed soil.

The technical revegetation standard will be 21% live vegetative cover (based on 70% of the Ecological Site Description cover estimate) within the area of disturbance to be eligible for full release from the New Mexico Mining Act ("NMMA"). Stoneworld Company Inc. may apply for full release from the NMMA as early as five years after reclamation and seeding of the site.

- 7. A fence and/or barrier and signage will be installed on top of the highwall to prevent vehicles and foot traffic from approaching the highwall unknowingly from behind.




Figure 1. Approximate Location of Proposed Access Road Water Bars

- 8. Access Road Water bars will be placed at strategic locations along the road, as shown in Figure 1 below, to channel water off the road toward the down-sloped side, to avoid erosion. The road will remain open to allow multiple use access to the area.
