I am writing in response to your request for comment on the above referenced permit modification received at this office September 9, 2020

Pursuant to 19.10.5.505 NMAC, Permit Modifications and Revisions, the Director shall determine whether a permit modification would have an adverse impact on cultural resources listed on either the National Register of Historic Places or the State Register of Cultural Properties or be located in a known cemetery or other burial ground.

According to our files, there are no cultural resources listed on either the National Register of Historic Places or the State Register of Cultural Properties in the modified permit area. There are also no known cemeteries or other burial grounds. Based on this information, this permit modification will have no adverse impacts to cultural resources listed on the National or State Registers.

Although there are no cultural resources listed on either the National Register of Historic Places or the State Register of Cultural Properties, the permit area land is leased from the City of Deming, and as such, this property is subject to regulations specified in the New Mexico Cultural Properties Protection Act (N.M. Stat. §§ 18-6A-1 through 6). As the mine permit area has never been archeologically surveyed and as a large archaeological site is located adjacent to the permit area, this office recommends that a cultural resources survey be conducted on undisturbed portions of mine property where proposed new ground disturbance will occur resulting from this permit modification.

This survey should be performed by a qualified professional to determine if any historic or archaeological properties are present and if so, to provide documentation of those resources to our office. This information can then be used to evaluate the National Register of Historic Places eligibility of any resources identified during

## Mining Environmental Compliance Section (MECS)

The MECS has previously inspected this facility numerous times. Recent inspections have indicated that the corrective actions conducted in 2018 are currently stable and effectively isolating the tailing material from the adjacent Mimbres River channel. Although the site is now stable, given the thin cover system and history of erosion issues the site will likely require future maintenance to ensure long-term stability. The applicant also is pursuing termination of Discharge Permit (DP) 1234. Any correspondence associated with this termination will be sent to MMD.

#### **NMED Summary Comment**

NMED finds that full release of this site under the NM Mining Act is commensurate with the request made to NMED to terminate DP-1234 and that the applicant has demonstrated compliance with the requirements in the Discharge Permit and met the applicable requirements of the NM Water Quality Control Commission Regulations under 20.6.2 NMAC.

The New Mexico Air Quality Bureau (AQB) has completed its review of the above-mentioned mining project. Pursuant to the New Mexico Mining Act Rules, the AQB provides the following comments.

## **Air Quality Permitting History**

The AQB has not issued any air quality permits for this operation.

## **Details**

Imerys/American Minerals Inc. (AMI) is requesting for its Deming Jigging Site, Permit No. LU001RE, a change of PMLU from "Grazing and Wildlife" to "Industrial", a release of all Financial Assurance, and full release from the jurisdiction of the New Mexico Mining Act. The site is fully-reclaimed and non-operational. The City of Deming owns the 20-acre site which was used by AMI for the processing of manganese ore.

## **Air Quality Requirements**

The New Mexico Mining Act of 1993 states that "Nothing in the New Mexico Mining Act shall supersede current or future requirements and standards of any other applicable federal or state law." Thus, the applicant is expected to comply with all requirements of federal and state laws pertaining to air quality.

There are no air quality requirements for a PMLU designation change to "Industrial". No physical processes are involved.

#### **Recommendation**

A change in PMLU status has no effect on air quality issues. The AQB therefore defers to MMD on the Permittee request for modification of PMLU designation and complete release of Financial Assurance and New Mexico Mining Act jurisdiction.

On September 10, 2020, NMED received a request for comments regarding a modification to an existing, regular mine permit located within the city of Deming in Luna County.

## Summary of Proposed Action

Imerys/American Minerals Inc ("Applicant") seeks to modify their mine permit to change the existing Post-Mining Land Use (PMLU) designation from Grazing to Industrial. In addition, the applicant requests release of all remaining financial assurance related to reclamation. Land ownership of the 20-acre property will remain with the City of Deming who may develop the site at some point in the future.

## Relevant State and Federal Water Quality Regulations

The Mimbres River lies just adjacent to the jigging site on the eastern boundary but does not typically receive stormwater from the site due to earthen berms that prevents surface water movement beyond the reclaimed area. The Mimbres River in that area is subject to water quality standards described in 20.6.4.98 NMAC for intermittent waters to protect the following designated uses: livestock watering, wildlife habitat, marginal warmwater aquatic life and primary contact.

## Recommendations to protect Surface Water Quality

The corrective action to stabilize areas of fugitive manganese tailing material in 2018 has been largely successful with most areas showing good coverage of native plant species or armoring in the form of larger diameter cobble. Provided that the Industrial PMLU continues to adequately protect the facility from erosion and tailing exposure, the proposed permit modification is likely to have negligible impact on surface water quality. The SWQB recommends approval of the PMLU change and release of all remaining financial assurance.
