The New Mexico Mining and Minerals Division ("MMD") has received the workplan from Summa Silver Corp. requesting approval of road maintenance work for Fannie Road (Catron County C-040/Forest Service Road FS4056O) during Mexican spotted owl and migratory bird breeding and fledgling season. MMD requested comments on the workplan from the New Mexico Department of Game and Fish ("DGF"). Based on the comments received from DGF, MMD approves commencement of the road repair workplan only after completion of two spotted owl surveys verifying that spotted owl pairs have not moved to another nest site location that is less than 0.5 miles from the proposed road work or after the breeding and fledgling season has ended. Further, MMD approves road repair activities to be conducted only from two hours after sunrise until two hours before sunset.

The New Mexico Department of Game and Fish (Department) has reviewed the Workplan for Road Repair (Plan) submitted by Summa Silver. Summa Silver is requesting permission to repair Fannie Road (Catron County C-040) and Forest Service Road FS4056O north of Mogollon, NM, during the Mexican spotted owl (MSO) closure and migratory bird survey season (March 1 – August 31). Summa Silver anticipates the road repair work to be completed within two to three days on approximately 1.23 miles of road. The repairs would require three to five loads of rock to be applied with the aid of a backhoe. The Department provides the following comments to minimize potential impacts to the MSO.

The proposed road work will occur at least 0.5 miles (i.e., recommended buffer distance) from the two active MSO nest sites that were identified in 2022 by NV5 using the U.S. Fish and Wildlife Service's MSO Survey Protocol. The road work is at least 1.5 miles from the further of these two nest sites. The Department recommends delaying road work until at least two rounds of year two MSO surveys have been completed to verify that the MSO pairs have not moved to another nest site location that is less than 0.5 miles from the proposed road work.

To minimize potential impacts to MSO foraging behavior, the Department recommends that road work operations be limited to one to two hours after sunrise until one to two hours before sunset during the MSO breeding and fledgling-dependency period (March 1 – August 31).

The Department also recommends that Summa Silver consult with the U.S. Fish and Wildlife Service for concurrence with the Department's recommendations and for any additional concerns or mitigation measures related to the proposed Plan.
