The New Mexico Mining and Minerals Division (MMD) is currently processing an application to revise Permit No. GR010RE, Tyrone Mine and Mill (Revision 21-1) operated by Freeport-McMoRan Tyrone Operations (Tyrone). Revision 21-1, referred to as the Emma Pit Expansion, proposes to mine a new open pit unit and develop three new stockpiles. MMD has sent several technical comment letters to Tyrone regarding Revision 21-1, including a most recent letter on June 13, 2023. Staff from MMD and Tyrone met to discuss the contents of this letter on July 6, 2023. This letter serves as a follow-up to the June 13, 2023 letter to provide clarification on MMD's comments number 4 and 11.

MMD will draft a permit condition based on comment number 4 rather than be required as an additional submittal prior to the Closure/Closeout Plan being deemed technically approvable. In addition, MMD will work with the New Mexico Environment Department (NMED) to jointly review the site-wide feasibility analysis submitted to NMED on September 20, 2022, titled *Open Pit Highwall Risk Analysis Work Plan – Tyrone* (Work Plan). This joint review of the Work Plan will address MMD comment number 11 and will be reviewed by MMD as it relates to wildlife and human health and safety for the Emma Pit, pursuant to §19.10.5.508 NMAC.
