Hi DJ -

I took a look at the permit too and found that a few things have changed since it was originally approved. I would like to change the proposed number of drill holes to 6 so that the Minimal Exploration Permit matches the Plan of Operations approved by the BLM. This would change the total disturbance to about 3 acres. In addition, I also can now include Cultural Resource and Wildlife Surveys in the application. Initially, I will be the operator, but in the not too distant future I hope to be entering into a lease purchase agreement with a Vancouver, BC based exploration company who will probably take the project over at some point in time.

There are few other changes too like the total number of claims, the drilling contractor and the project map. I would propose sending MMD an updated application.

Another thing I would like to have included in the approval is being able to transfer the bond from one drill site to another upon completion of a hole. Because of the shallow nature of the drill holes, drilling

should proceed rather quickly and in order to minimize drill rig standby time and as soon as the drill hole is plugged, I can move the drill to the next site. The actual drill pad probably cannot be reclaimed for several days after the hole is completed as the sump will need time to evaporate.

I have completed the revised application, just waiting for my draftsman to complete the revised map. I should be able to send you the revised application and map by Monday.

As for the documents requested by Clint, I have the approval from the NMSLO in hand for the Right to Access State Land. I can also provide a list of my recorded claims on file with the BLM. Please be advised that I am in the process of relocating many of my claims, but currently taking a break because of the extreme heat on the Playa. As soon as I have completed the restaking, I will start the recording process with Hidalgo County and the BLM soon. As for the access agreement from Kinder Morgan, KM has told me that they need a letter from the BLM stating that it is OK for me to use KM's ROW for accessing my drill sites before they will sign my application to use their ROW. I requested a letter from Anthony Hom in the BLM's Las Cruces District Office 6 months ago and sent him a reminder yesterday, I don't anticipate any problems getting the letter from Anthony.
