#### Section 1. PERMIT APPLICATION PACKAGE

- A. The Permit Application Package ("PAP") for permit transfer is comprised of:
  - 1. A letter from the Applicant requesting permit transfer, and signed by both the Applicant and the Transferor, dated September 26, 2023.
  - 2. Approved Joint Surety Bond Rider to Surety Bond No. 82458927 with the New Mexico Environment Department from Federal Insurance Company changing the Principle from LAC Minerals (USA) LLC to Homestake Mining Company of California. No change has been made to the original amount of \$401,741.00.
  - 3. Public Notice affidavit of publication from the Santa Fe New Mexican, dated October 9, 2023.

#### Section 2. FINDINGS OF FACT

A. Pursuant to §19.10.8.802.B NMAC, the Applicant has filed the required public notice with the Santa Fe New Mexican with all required information, published October 9, 2023.

- B. Pursuant to §19.10.8.802.C NMAC, notice of this permit transfer was provided by the MMD Director to the Environment Department, the Office of the State Engineer, the Department of Game and Fish, the Forestry Division, and the State Historic Preservation Division on October 12, 2023.
- C. Pursuant to §19.10.8.802.D(1) NMAC, the Applicant has provided financial assurance in the form of a Surety Bond Rider to Surety Bond No. 82458927 with the New Mexico Environment Department from Federal Insurance Company changing the Principle from LAC Minerals (USA) LLC to Homestake Mining Company of California. No change has been made to the original amount of \$401,741.00..
- D. Pursuant to §19.10.8.802.D(2) NMAC, the Applicant agrees to continue to conduct the operations involved, in full compliance with the New Mexico Mining Act ("Act"), the New Mexico Mining Act Rules ("Rules"), and the terms and conditions of the Permit, as may be revised or modified.

- G. Pursuant to §19.10.8.802.E NMAC, this permit transfer notifies the current Transferor, the Applicant, and the owner of the mineral estate of the MMD Director's findings.
- H. Pursuant to §19.10.8.802.F NMAC, the Applicant has provided notice to the MMD Director of the consummation of the transaction transferring the Cunningham Hill Mine Reclamation Project from Transferor to Transferee.
