### **ACCESS NOTES:**

When turning off the highway, there is a locked gate on the road. There was a second opening/gate installed just beside it that was open/not locked.

There was no other gate encountered, when arriving at the residence on site, stay to the left.

### **PERMIT STATUS**

No new actions – Permit is "dormant". It has been ~5.5 years since an inspection was last performed (Oct. 2019). There is little institutional knowledge on this site. This Inspection report also works as a full permit file review to pull in historical context for the site.

### **INSPECTION NARRATIVE AND PHOTOS**

Arrived on site at 11:30. Operator had never responded to previous request for an inspection, MMD staff performed the inspection without Operator Present. Main goal was for initial review of site and determine current conditions, MMD staff accomplished this by walked the site. Significant trash/debris throughout the site. All fencing was falling down throughout the site. There were significant piles of various types of material, seemingly in no order.

Did not visit the cement pad behind the residence on the west side of the permit area. Discrepancies between original permit mapping and more recent mapping didn't indicate the cement pad area being in the current permit area – however it appears the cement pad/USFS

property was used in Mining activities at some point and this needs to be resolved (see also 2019 inspection)

On desktop review general disturbance is 11.15 acres (see figure 2). This doesn't include the residence or the cement pad area. Additional items of note following a detailed file review on the site:

- Each 5-acre section should have been reclaimed after each "phase" was completed
   → All areas under this permit appeared as active disturbance with no re-grading or
   appearance of reclamation.
- Original Permit included the cement pad, but later modifications dropped this area. In Original application documents there was a "plant" on the cement pad, and facilities where the residence are. → need to verify associated mine disturbance and what reclamation has been done or needs to be done.
- On imagery review, a small pad appears to have been used in mining that is on Forest Service Land.
- Residence may no longer be associated with Mine activities. Part of the Permit,
   Parcel map shows the claim parcel may have been split.




FIGURE 1 PARCEL MAPS OF PITSBURG LODE




FIGURE 2 DISTURBANCE AREA




FIGURE 3 FEATURES ON SITE – BLUE DOTS WERE MARKED "ACTIVE" PITS IN PERMIT DOCUMENTS.






FIGURE 26 UNRECLAIMED PILE
