Legal Notice

Pursuant to the New Mexico Mining Act Rules, 19.10.4 and 19.10.9.903 A through I NMAC, in 2024, Freeport-McMoRan Tyrone Inc. (Tyrone) applied to the Mining and Minerals Division, New Mexico Energy, Minerals and Natural Resources Department (MMD) for an exploration permit (GR095ER) in an area called the Emma Project. MMD issued the permit in 2025.

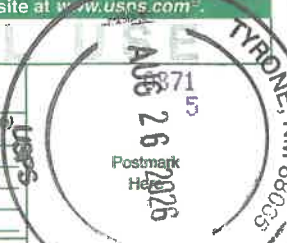

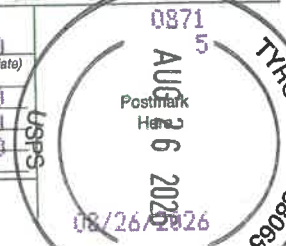
