Acoma ALL PUEBLO COUNCIL OF GOVERNORS Cochiti **RESOLUTION NO. 2024-12 REAFFIRM PROTECTIONS FOR MT. TAYLOR AND OPPOSITION TO THE** Isleta PROPOSED LARAMIDE RESOURCES LA JARA MESA URANIUM MINE **PROJECT** Jemez WHEREAS, the All Pueblo Council of Governors is comprised of the New Mexico Laguna Pueblos of Acoma, Cochiti, Isleta, Jemez, Laguna, Nambe, Ohkay Owingeh, Picuris, Pojoaque, San Felipe, San Ildefonso, Sandia, Santa Ana, Santa Clara, Santo Domingo, Nambe Taos, Tesuque, Zia, and Zuni and one Pueblo in Texas, Ysleta del Sur, each having the sovereign authority to govern their own affairs; Ohkay Owingeh WHEREAS, the purpose of the All Pueblo Council of Governors is to advocate, foster, protect, and encourage the social, cultural, and traditional well-being of the Pueblo Picuris Nations; WHEREAS, the 20 Pueblos possess governmental authority and sovereignty over Pojoaque their lands and protection of their languages, cultures, and traditions; Sandia WHEREAS, the Pueblos possess their own cultural territory and sovereign rights to protect their cultural resources, including their traditional cultural properties and sacred San Felipe sites, whether or not these cultural resources are located within each Pueblo's current exterior boundaries: San Ildefonso WHEREAS, the All Pueblo Council of Governors is the successor organization to the All Indian Pueblo Council (AIPC), which previously advocated for the protection of Santa Ana Mt. Taylor through multiple resolutions, including AIPC Resolution 2006-19, 2007-12, and 2008 reaffirming support for the protection of Mt. Taylor and all sacred sites related to the Santa Clara Pueblos: Santo Domingo WHEREAS, Mt. Taylor, known by various traditional names is a sacred landscape, central to the cultural identity, traditional practices, and religious activities of numerous Pueblos and other tribal nations; Taos WHEREAS, in 2009, following significant advocacy by Pueblos and other tribes, Tesuque Mt. Taylor was determined eligible as a Traditional Cultural Property (TCP) for the National Register of Historic Places, recognizing its profound cultural significance and the Ysleta del Sur necessity of its protection; Zia

Acoma Cochiti	WHEREAS, in a landmark 2014 decision (<i>Rayellen Res. Inc. v. N.M. Cultural Props. Review Comm.</i>), the New Mexico Supreme Court affirmed the validity of Mt. Taylor's cultural property designation, and listing on the New Mexico State Register of Cultural Properties, recognizing the mountain's significance;
Isleta Jemez	WHEREAS, the United States Mining Law of 1872 remains an outdated and unjust law that continues to prioritize mining over the protection of Indigenous sacred sites and cultural landscapes, failing to recognize the vital importance of preserving irreplaceable cultural resources for future generations;
Laguna Nambe	WHEREAS, Mt. Taylor and the surrounding tribes, geographic region, and communities have already suffered extensive environmental damage from previous uranium mining activities, contaminating groundwater, creating lasting health impacts on local and tribal communities, and degrading this sacred landscape;
Ohkay Owingeh Picuris Pojoaque	WHEREAS, Laramide Resources Ltd. has proposed the La Jara Mesa Underground Uranium Mine within the boundaries of the Mt. Taylor TCP, and when fully operational would extract approximately 7.2 million pounds of uranium over 16-20 years through 24/7 operations;
rojoaque	WHEREAS, this proposed mining operation threatens to:
Sandia San Felipe	 Disrupt and disfigure sacred landscapes and cultural sites through blasting and heavy equipment operations; Impact groundwater resources through the extraction of groundwater from the
San Ildefonso Santa Ana	 San Andres Glorieta Aquifer which is already over appropriated. The Aquifer is the primary source of surface water for the Pueblos of Acoma and Laguna; Create environmental and public health hazards through uranium ore transportation, storage, and potential land, water, and natural resources
Santa Clara Santo Domingo	 contamination; Generate significant noise and light pollution through 24/7 operations; Fundamentally and forever alter the character, viewshed, integrity, and cultural worldview of this sacred landscape;
Taos	WHEREAS, previous environmental review of this project in 2012 failed to adequately address impacts to cultural resources, water resources, wildlife, and cumulative impact on the environment;
Tesuque Ysleta del Sur	WHEREAS , the protection of Mt. Taylor is essential for the continuation of traditional cultural practices and the preservation of Pueblo cultural identity;

Acoma	NOW THEREFORE BE IT RESOLVED , that the All Pueblo Council of Governors strongly opposes the proposed Laramide Resources La Jara Mesa Uranium Mine project and calls upon federal and state agencies to deny all permits and authorizations for this
Cochiti	project;
Isleta	BE IT FURTHER RESOLVED , that the All Pueblo Council of Governors demands that the U.S. Forest Service, in its role as federal land manager, uphold its trust responsibility to protect this sacred landscape and deny any permits or authorizations that
Jemez	would compromise the integrity of the Mt. Taylor TCP designation;
Laguna	BE IT FURTHER RESOLVED , that the All Pueblo Council of Governors calls upon the New Mexico Mining and Minerals Division and Environment Department to recognize
Nambe	the cultural significance of Mt. Taylor in their regulatory processes and deny state permits that would enable this destructive project;
Ohkay Owingeh	BE IT FURTHER RESOLVED, that the All Pueblo Council of Governors calls upon
Picuris	Congress to reform the 1872 Mining Law to better protect Native American sacred sites, cultural properties, and water resources from destructive mining activities, and to require meaningful tribal consultation in mining decisions that affect tribal cultural resources;
Pojoaque	BE IT FURTHER RESOLVED, that the All Pueblo Council of Governors requests
Sandia	that Congress consider legislation to permanently protect Mt. Taylor from mining activities, recognizing its irreplaceable cultural value to Pueblo people and other tribes;
San Felipe	BE IT FURTHER RESOLVED , that the All Pueblo Council of Governors directs that
San Ildefonso	copies of this resolution be transmitted to the Secretary of the Interior, Secretary of Agriculture, New Mexico Congressional Delegation, Governor of New Mexico, the New Mexico Land Commissioner, relevant state and federal agencies, and other interested
Santa Ana	parties;
