- 1. the amount of financial assurance sufficient to cover third-party costs of sealing, subsurface plugging, and surface reclamation of drill holes; and
- 2. the number of unabandoned and reclaimed drill holes at any one time.

Condition 10.HH, Financial Assurance of Permit Modification 22-1 to Permit No. GR083EM is hereby replaced with:

Financial Assurance

A. The Permittee shall maintain FA, after approval of this Permit Modification 22-1, in the approved amount of \$229,922.00 00 (two hundred twenty-nine thousand nine hundred twenty-two dollars), using one or more approved FA instruments, pursuant to Part 12 of the Rules and sufficient to cover third-party costs of sealing, subsurface plugging, and surface reclamation of sixteen (16) drill holes, and nine (9) drill pad areas, and access roads. The Permittee shall plug and abandon and reclaim the drill pads immediately after drilling is complete for each drill hole and shall not exceed 12 unabandoned and reclaimed drill holes at any one time.

All other provisions, and modifications for mining and reclamation contained in the Emma-B Exploration Project Permit No. GR083EM, remain unchanged.
