

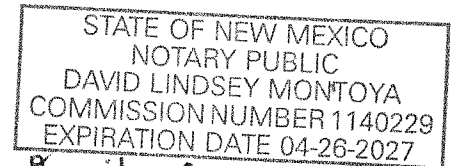

The Tijeras Mine and Mill is a limestone quarry and processing plant which operates to produce cement, a raw material in the batching of concrete for building and construction. GCC has submitted the application for Revision 23-1 to update the Mine Closeout Plan for the facility.
