Pursuant to 19.8.14.1412 NMAC, enclosed for MMD review and approval is the application for a Phase 1 bond release for completion of final backfilling, grading and approved final surface configuration within approved drainage control. El Segundo Mine permit areas are labeled 34-42 totaling 458.07 acres, which equates to 7.2% of the 6378.68 disturbed acres or 2.77% of the 16,559 permitted acres as described in this application. Backfilling and grading have been completed in these areas, and no ungraded spoil or open pits remain. This bond release application does include a request for a reduction in \$1,097,141.78 actual bond monies posted.

Introduction

This document constitutes Peabody Natural Resources Company's application for a Phase 1 bond release for backfilled and graded areas at the El Segundo Mine labeled as Areas 34-42 (458.07 acres) described in this application and shown on Exhibit 1. Areas 1-33 2430.31 acres have previously been submitted under a Phase 1 bond release application in 2016, 2017, 2018 and 2019. Backfilling and grading has been completed in these previously mined areas and the work has been documented and reported in annual reports to the Mining and Minerals Division (MMD). The postmine topography achieved through backfilling and grading has been documented and included in annual reports to MMD since 2009. This application has been ordered and formatted to follow the requirements of 19.8.14.1412.A, NMAC.

19.8.14.1412 A. (2) (b) Legal Description

The Phase 1 bond release is requested for lands within the El Segundo Mine permit (McKinley County New Mexico). The general legal description of the requested release areas (based on Section, Township and Range as specified in the Bond Release Guideline) is listed below and locations are shown on Plates 1-A (Flight Contour Map) and 1-B (USGS Topography Map) in this application.

The acres associated with the Phase 1 2020 release are within Sections 25, 26, 27, 35, 36 and 31 of T17N R10W in the Laguna Castillo, USGS Section 1 of T16 R10W in Orphan Annie Rock USGS Quad maps. USGS Sections 3 of T16, R9W in Orphan Annie Rock USGS Quad maps; Sections 31, 32, 33 and 34 of T17N, R9W in Orphan Annie Rock USGS Quad Maps. USGS Sections 1 of T16N, R10W in Orphan Annie Rock USGS Quad maps.

19.8.14.1412 A. (2) (c) Location

The El Segundo Mine permit area encompassing the lands requested for Phase 1 release are in McKinley County approximately 35 miles North of Grants, New Mexico. The centroid location of the release area parcels is approximately latitude 35°39'20" N and longitude 107°51'05" W. The areas requested for Phase 1 release are outlined in Plates 1-A (Flight Contour Map) and 1-B (USGS Topography Map).

19.8.14.1412 A. (2) (d) History and Reclamation Summary

The El Segundo Mine began operations in 2006 under Peabody Natural Resources Company. The operation is an open cut surface coal mine recovering several seams of coal. The overburden is removed using a combination of truck, shovel, and dragline stripping methods. Coal has been delivered to southwestern regional customers. Reclamation operations began in 2012. Upon removal of the coal, the open cut was backfilled primarily with truck hauled spoil, and at times assisted by the dragline. Once sufficient spoil had been backfilled or placed in approved locations, grading to the approved postmine topography is completed. Topsoil or approved soil substitutes is then spread on the regraded surface and seeded with the approved seed mix. Backfilling, grading, topsoiling, and reseeding have been conducted to create a stable landscape in conformance with the approved post-mining contours in the permit. Reclamation procedures support achievement of the postmining land use of livestock grazing. The El Segundo Surface Coal Mine Performance Bond for permit 2015-01 is \$62,223,730.00 to ensure the successful reclamation of disturbance within the 16,559.02-permit area dated April 5, 2016.

The Phase I release in this application is being sought for the areas listed below and shown on Plates 1-A (Flight Contour Map) and 1-B (USGS Topography Map). Disturbance and reclamation history for Areas 34-42 are summarized below in Table 1 and have been reported to MMD in Annual Reclamation reports covering the activity years listed. Spoil material has been analyzed for suitability and mitigated with suitable material in cases the soil is unsuitable for spoil material. The results are included in the Annual Report.

Thus, the Phase I request constitutes simply a release of the activities included under Phase I. There is a request of \$1,097,141.78 as a reduction in the bond for the current operation as a result of the Phase 1 bond release application.

Peabody Natural Resources Company has filed for a Phase 1 bond release for completion of backfilling, and grading, and approved final surface configuration of land at the El Segundo Mine lands pursuant to Section 19.8.14.1412(A) of the New Mexico Administrative Code (NMAC). The application has been filed with the New Mexico Mining and Minerals Division (MMD) of the Energy, Minerals & Resources Department in Santa Fe, New Mexico. All reclamation activities for Phase 1 bond release were completed in accordance with the New Mexico Surface Mining Act (NMSA) and pursuant to Title 19, Chapter 8 of the NMAC.

El Segundo Mine's headquarters is located 35 miles north of Milan, NM on both sides of State road 509 with a mailing address at P.O. BOX 757, Grants, NM, 87020. The current permit number for the El Segundo Mine regulated by the State of New Mexico Mining and Minerals Division is 2015-01, which was granted in 2015.
