The New Mexico Mining and Minerals Division (MMD) is notifying Laramide Resources that the recently submitted Mining Operations and Reclamation Plan (MORP) dated December 2025 for the proposed La Jara Mesa Uranium Mine has been received and is Administratively Complete. Laramide Resources (USA) Inc. announces that a Mine Operations and Reclamation Plan (MORP) for its La Jara Mesa Project, part of the New Mine Permit Application, has been submitted to the New Mexico Mining and Minerals Division (MMD) pursuant to §19.10.6.602(D) (15) of the New Mexico Mining Act Rules. MMD has determined the MORP to be administratively complete and will now distribute the MORP to other reviewing agencies and begin technically reviewing the application. The MORP is a component of the Permit Application Package, which is still under technical review.

The New Mine Permit Application proposes the development of an underground uranium mine located approximately 10 miles north of the town of Grants, in Cibola County New Mexico.
