 - c. Farmington Public Library
 - d. La Plata Mine Entrance (gate)
2. Publishing a notice in a display ad at least three inches by four inches at a place in the newspaper calculated to give the general public the most effective notice;
 - a. Tri-City Record
3. Broadcast public service announcements on radio stations that serve the general permit area
 - a. KTRA 102.1 FM Farmington, NM
 - b. KENN 1390 AM Farmington, NM
 - c. KTNN 660 AM Farmington, NM
