This letter responds to your October 21, 2020 letter regarding the proposed Modification 20-1 to the Mt. Taylor Mine Permit No. CI002RE. The Mining and Minerals Division ("MMD") appreciates your comments and will consider them in the permitting process for Modification 20-1.

As you may be aware, MMD provided our comments along with the comments of other state agencies to Rio Grande Resources Corporation ("RGR"), the operator of the Mt. Taylor Mine, on the proposed update to the Reclamation Schedule, the proposed expansion of the South Waste Rock Pile and Disposal Cell, and the proposed changes to the Post-Mining Land-Use requested in the application to modify the Mt. Taylor Mine permit. MMD comments also include concerns with the 2016 Mt. Taylor Mine Reclamation Cost Estimate that was approved by MMD under Revision 13-2.
