Hearing no objection Chairman King asks for a motion. Mr. Bemis moves to waive the notice requirements in the guidelines to allow for a 30-day notice period consistent with the statute, with second by Mr. Apodaca. Motion passes unanimously on a voice vote.

Chairman King suggests a hearing date on MMD petition 05-01 of November 16, 2005. Mr. Core moves to set a hearing date on November 16, 2005 at 9 A.M. in Porter Hall, with second by Ms. Watchman-Moore. Motion passes unanimously on a voice vote.
