## 1. Roll call

The Commissioners announce their own names.

## 2. Approval of agenda

Mr. Kehoe moves to adopt the agenda, with second by Mr. Rogers. Motion passes unanimously on a voice vote.

### 3. Adoption of the minutes of the October 5, 2000 Meeting and Hearing

After the Commission takes a moment to review the minutes, there is a motion by Mr. Briggs to approve the minutes, as presented; second by Mr. Thomson. The motion passes unanimously on a voice vote.

## 4. Consideration of pending litigation: San Pedro Neighborhood Association v. NMMC et al.

Mr. Rubin discusses legal aspects of the Joint Motion to Dismiss Appeal; Mr. Freeman briefly discusses the interactions between St. Cloud Mining Co. and the San Pedro Neighborhood Association. Motion by Mr. Stevenson to approve the Joint Motion as presented; second by Mr. Scholle. The motion passes unanimously on a voice vote.

# 5. Public hearing on Challenge Mining Company's appeal (00-03) of the Director's Order assessing penalties for Notice of Violations N00-7-1 and N00-7-2 and directing the Company to pay the penalty assessments and annual fees pursuant to the NOVs

Chairman Fletcher asks Challenge Mining Company's representative to step forward. No one steps forward. Chairman Fletcher asks MMD Counsel Mr. Rogoff whether he has anything further to add. Mr. Rogoff states that he has no statements beyond what was provided in his response brief. Mr. Bland responds to several questions from Chairman Fletcher on the Challenge situation. Motion by Mr. Briggs to uphold the Director's order and to deny the Challenge petition. The motion is amended by Mr. Maggiore: to direct Counsel to develop an order indicating same; to give the Chairman the ability to sign the order without the Commission having to reconvene; and to include in the final order language expressing the Commission's frustration and disappointment that Challenge did not appear before them. Motion is seconded Mr. Kehoe. The motion passes unanimously on a voice vote.

#### 6. Other business

Mr. Bland states that a petition for amendment of the fee schedule will occur in the next several months. There is some discussion on the terms of commissioners. Mr. Kehoe states that the State Land Office has drafted a sand and gravel regulation. There is some discussion on the status of attempts to reduce the number of frivolous appeals.
