SE/4 NW/4 (Unit F) of Section 21, to a bottom hole location in Lot 3 (NW/4 SW/4 equivalent) of Section 19; (4) Wave Race Fed Com 114H well, to be drilled from a surface location approximately in the SW/4 NW/4 (Unit E) and SE/4 NW/4 (Unit F) of Section 21, to a bottom hole location in Lot 4 (SW/4 SW/4 equivalent) of Section 19; (5) Wave Race Fed Com 121H well, to be drilled from a surface location approximately in the SW/4 NW/4 (Unit E) and SE/4 NW/4 (Unit F) of Section 21, to a bottom hole location in Lot 1 (NW/4 NW/4 equivalent) of Section 19; (6) Wave Race Fed Com 122H well, to be drilled from a surface location approximately in the SW/4 NW/4 (Unit E) and SE/4 NW/4 (Unit F) of Section 21, to a bottom hole location in Lot 2 (SW/4 NW/4 equivalent) of Section 19; (7) Wave Race Fed Com 123H well, to be drilled from a surface location approximately in the SW/4 NW/4 (Unit E) and SE/4 NW/4 (Unit F) of Section 21, to a bottom hole location in Lot 3 (NW/4 SW/4 equivalent) of Section 19; and (8) Wave Race Fed Com 124H well, to be drilled from a surface location approximately in the SW/4 NW/4 (Unit E) and SE/4 NW/4 (Unit F) of Section 21, to a bottom hole location in Lot 4 (SW/4 SW/4 equivalent) of Section 19. Said area is located approximately 3.5 miles northeast of Aztec, New Mexico.

The proposed wells have orthodox locations. The 334H Well is designated as the proximity well, and proximity tracts will be utilized. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs thereof; actual operating costs and charges for supervision; the designation of the Applicant as Operator of the wells and unit; and a 200% charge for the risk involved in drilling and completing the wells. The wells and lands are located adjacent to the southern state line and approximately 31 miles southeast of Carlsbad, New Mexico.
- **8.** Case No. 25612: Application of WPX Energy Permian, LLC, for Compulsory Pooling, Eddy County, New Mexico. The

proposed wells have orthodox locations. The 332H Well is designated as the proximity well, and proximity tracts will be utilized. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs thereof; actual operating costs and charges for supervision; the designation of the Applicant as Operator of the wells and unit; and a 200% charge for the risk involved in drilling and completing the wells. The wells and lands are located adjacent to the southern state line and approximately 31 miles southeast of Carlsbad, New Mexico.

- 9. Case No. 25613: Application of Spur Energy Partners LLC for Compulsory Pooling, Eddy County, New Mexico. Applicant seeks an order pooling all uncommitted interests from the top of the Yeso formation at 3,900' MD to the base of the Blinebry at 5,240' MD underlying a 480-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Section 9 and the NE/4 of Section 8, Township 17 South, Range 29 East, Eddy County, New Mexico ("Unit"), Applicant seeks to dedicate the Unit to the following wells ("Wells"): Peaky 9-8 State 20H and Peaky 9-8 State 70H wells, to be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 10 to a bottom hole location in NW/4 NE/4 (Unit B) of Section 8; and Peaky 9-8 State 21H well, to be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 10 to a bottom hole location in SW/4 NE/4 (Unit G) of Section 8. The completed interval of the well will be orthodox. Due to a depth severance within the Unit, Applicant seeks to pool uncommitted interests from the top of the Yeso formation at a stratigraphic equivalent of 3,900' MD to the base of the Blinebry at a stratigraphic equivalent of 5,220' MD as observed on the Chaser 8 State #2 well Schlumberger Sidewall Neutron Porosity Log (API No. 30-015-37807). The completed interval of the Peaky 9-8 State Com 70H well will be located within 330' of the quarter-quarter section line separating the S/2 N/2 and the N/2 N/2 of Section 9 and the N/2 NE/4 and S/2 NE/4 of Section 8 to allow for the creation of the 480-acre standard horizontal spacing unit. Also to be considered will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells. The Wells are located approximately 2.39 miles north and 4.97 miles west of Loco Hills, New Mexico.
- 10. Case No. 25614: Application of Devon Energy Production Company LP for Compulsory Pooling and Approval of Overlapping Spacing Unit, Eddy County, New Mexico. Applicant applies for an order pooling uncommitted interests in the Bone Spring formation underlying a 319.64-acre, more or less, standard, overlapping horizonal spacing unit comprised of the E/2 W/2 of Section 11 and the E/2 W/2 equivalent of irregular Section 2, Township 23 South, Range 31 East, Eddy County, New Mexico ("Unit"). The Unit will be dedicated to the Belloq 11-2 Fed State Com 122H, Belloq 11-2 Fed State Com 123H, and Belloq 11-2 Fed State Com 534H wells ("Wells"), which will be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 11 to a bottom hole location in Lot 3 (NE/4 NW/4 equivalent) of Section 2. The Unit will partially overlap with the spacing units for the following wells, which produce from the Livingston Ridge; Bone Spring Pool (Code 39350): Belloq 2 State #005H (API No. 30-015-42896), which is located in the W/2 E/2 of irregular Section 2, Township 23 South, Range 31 East; Belloq 2 State #006H (API No. 30-015-42897), which is located in the W/2 E/2 of Section 11, Township 23 South, Range 31 East. Also to be considered will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells. The Wells are located approximately 20.5 miles east of Loving, New Mexico.
- 11. Case No. 25615: Application of Mewbourne Oil Company for Compulsory Pooling, Eddy County, New Mexico. Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 238.17-acre, more or less, standard horizonal spacing unit comprised of the S/2 S/2 of Section 13, Township 18 South, Range 29 East, and the S/2 SW/4 of Section 18, Township 18 South, Range 30 East, Eddy County, New Mexico ("Unit"). The Unit will be dedicated to the Study Butte 18/13 Fed Com #528H well ("Well"), which will be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 20, Township 18 South, Range 30 East, to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 13, Township 18 South, Range 29 East. The completed interval of the Well will be orthodox. Also to be considered will be the cost of drilling and completing the Well, the allocation of the costs, the designation of Applicant as operator of the Well and the Unit, and a 200% charge for the risk involved in drilling and completing the Well. The Well is located approximately 22 miles east-southeast of Artesia, New Mexico.
- 12. Case No. 25616: Application of Mewbourne Oil Company to Extend Time to Complete Drilling Operations Under Order No. R-23512, Eddy County, New Mexico. Mewbourne Oil Company seeks an order extending the deadline to complete drilling the wells authorized by Order No. R-23512 until October 23, 2026. The Order: pooled all uncommitted interests in the Bone Spring formation underlying a 1,924.32-acre, non-standard horizontal spacing unit comprised of Sections 1, 2, and 3, Township 20 South, Range 27 East, Eddy County, New Mexico ("Unit"); dedicated the Unit to the Dama Dorado 1/3 Fed Com 626H and Dama Dorado 1/3 Fed Com 628H wells ("Wells"); and designated the Applicant as operator of the Unit and the Wells. The Order requires Applicant to complete drilling the Wells within one

year of spudding the Wells. Applicant has begun drilling the Wells but requests that the Division extend the deadline to complete drilling the Wells by one year. The Wells are located approximately 7 miles east-southeast of Lakewood, New Mexico.

- 13. Case No. 25617: Application of Mewbourne Oil Company to Extend Time to Complete Drilling Operations Under Order No. R-23522, Eddy County, New Mexico. Mewbourne Oil Company seeks an order extending the deadline to complete drilling the wells authorized by Order No. R-23522 until October 23, 2026. The Order: pooled all uncommitted interests in the Wolfcamp formation underlying a 1,920 -acre, non-standard horizontal spacing unit comprised of Sections 27, 28, and 29, Township 20 South, Range 27 East, Eddy County, New Mexico ("Unit"); dedicated the Unit to the Pinta 29/27 Fed Com 711H and Pinta 29/27 Fed Com 716H wells ("Wells"); and designated Applicant as operator of the Unit and the Wells. The Order requires Applicant to complete the Wells within one year after spudding the Wells. Applicant has begun drilling the Wells but requests that the Division extend the deadline to complete the Wells by one year. The Wells are located approximately 8 miles southeast of Lakewood, New Mexico.
- 14. Case No. 25618: Application of Mewbourne Oil Company to Extend Time to Complete Drilling Operations Under Order No. R-23521, Eddy County, New Mexico. Mewbourne Oil Company seeks an order extending the deadline to complete drilling the wells authorized by Order No. R-23521 until October 23, 2026. The Order: pooled all uncommitted interests in the Bone Spring formation underlying a 1,920-acre, non-standard horizontal spacing unit comprised of Sections 27, 28, and 29, Township 20 South, Range 27 East, Eddy County, New Mexico ("Unit"); dedicated the Unit to the Pinta 29/27 Fed Com 528H, Pinta 29/27 Fed Com 613H and Pinta 29/27 Fed Com 618H wells ("Wells"); and designated Applicant as operator of the Unit and the Wells. The Order requires Applicant to complete the Wells within one year of spudding the Wells. Applicant requests that the Division extend the deadline to complete the Wells by one year. The Wells are located approximately 8 miles southeast of Lakewood, New Mexico.
- **15. Case No. 25619: Application of Tascosa Energy Partners, LLC for Compulsory Pooling, Eddy County, New Mexico.** Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying 720-acre, more or less, standard horizontal spacing unit comprised of the S/2 NE/4 and N/2 SE/4 of Section 7, the N/2 S/2 and S/2 N/2 of Section 8, and the S/2 NW/4, N/2 SW/4, SW/4 NE/4 and NW/4 SE/4 of Section 9, Township 20 South, Range 26 East, Eddy County, New Mexico ("Unit"). The Unit will be dedicated to the Anna 79 Fee #203H well ("Well"), which will be drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 7 to a bottom hole location in the NW/4 SE/4 (Unit J) of Section 9. The completed interval of the Well will be orthodox. The completed interval of the Well will be located within 330' of the quarter-quarter section line separating the S/2 N/2 and N/2 S/2 of Sections 7, 8, and 9 to allow for the creation of a 720-acre standard horizontal spacing unit. Also to be considered will be the cost of drilling and completing the Well and the allocation of the cost, the designation of Applicant as operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well. The Well is located approximately 12 miles from Carlsbad, New Mexico.
