- 2. Case No. 25610: Application of Powderhorn Operating, LLC for Compulsory Pooling, Eddy County, New Mexico. Applicant seeks an order pooling all uncommitted interest within the Wolfcamp formation, designated as a gas pool (Purple Sage Wolfcamp [Gas] Pool Code 98220), underlying a 959.60-acre, more or less, standard horizontal well spacing unit comprised of the E/2 of Section 3 and all of Section 2, located in Township 24 South, Range 26 East, NMPM, Eddy County, New Mexico (the "Unit"). The wells will be horizontally drilled and located within the Purple Sage Wolfcamp Gas Pool (Code 98220). This pool is subject to special pool rules that establish 330-foot setback requirements, and the Wells will have non-standard first and last take points. The completed interval of the Wells will remain within 330 feet of the adjoining half-section tracts, allowing inclusion of these

proximity tracts within the proposed Unit under NMAC 19.15.16.15(B)(4). Also, to be considered will be the cost of drilling and completing the Wells and the allocation of the cost, the designation of Applicant as the operator of the Wells and Unit, and a 200% charge for the risk involved in drilling and completing the Wells against any working interest owner who does not voluntarily participate. Applicant in the above-styled cause seeks a year extension time for drilling the remaining wells under Order No. R-23452 in case number 24544. The Unit is composed of All of Sections 25 and 36, Township 18 South, Range 33 East, N.M.P.M., Lea County, New Mexico. Coterra Energy Operating Company is the designated operator under the pooling order. Order No. R-23452 pooled the uncommitted interests in the Bone Spring formation and dedicated the Unit to the proposed initial wells including: Royal Oak 25 Fed Com #301H Well (API No. 30-025-52841); Royal Oak 25 Fed Com #302H Well (API No. 30-025-52843); Royal Oak 25 Fed Com #303H Well (API No. 30-025-54153), Royal Oak 25 Fed Com #304H Wells (API No. 30-025-54154), Royal Oak 25 Fed Com #501H (API No. 30-025-54155), Royal Oak 25 Fed Com #502H (API No. 30-025-54156) formerly named the Royal Oak 25 Fed Com #504H Well, Royal Oak 25 Fed Com #511H Well (API No. 30-025-52846) formerly named the Royal Oak 25 Fed Com #601H Well, Royal Oak 25 Fed Com #602H Well (API No. 30-025-52847), Royal Oak 25 Fed Com #512H Well (API No. 30-025-52847), Royal Oak 25 Fed Com #512H Well (API No. 30-025-54158). Said Unit areas are located approximately 28 miles west from Hobbs, New Mexico.
- 6. Case No. 25679: Application of Enterprise Delaware Basin Treating LLC for Authorization to Inject, Lea County, New Mexico. Enterprise Delaware Basin Treating LLC ("Enterprise") (OGRID No. 330718) seeks authorization to drill, complete, and operate an additional redundant acid gas injection ("AGI") well at its Dark Horse Treating Facility. Enterprise proposes to inject treated acid gas ("TAG") into the proposed Independence AGI #3 well ("Well"), which will be located in Section 20, Township 25 South, Range 36 East, in Lea County, New Mexico.
