- 10. Case No. 25764: Application of Catamount Energy Partners, LLC to Extend the Drilling Deadline Under Order No. R-23651, San Juan and Rio Arriba Counties, New Mexico. Applicant in the above-styled cause seeks a year extension of time for drilling the wells under Order No. R-23651. The Unit is comprised of N/2 and the N/2 S/2 of Sections 13, 14 and 15, Township 32 North, Range 6 West, NMPM, San Juan and Rio Arriba Counties, New Mexico. Applicant in the above-styled cause seeks a year extension of time for drilling the wells under Order No. R-23613. The Unit is located approximately 21 miles southwest of Eunice, New Mexico.
