Item 5: Other business.

Action: Salt Creek Midstream LLC filed a Motion for Temporary Stay of December 28, 2022 Injection Deadline and for Expedited Hearing. Counsel Moander announced that the temporary stay has been granted and the Motion for Expedited Hearing has

been denied by the Acting Oil Conservation Division Director.

Counsel Moander announced that this will be his last hearing serving as Commission Counsel. He will be leaving the Attorney General's Office and has accepted a position with EMNRD's Office of General Counsel supporting the Oil Conservation Division starting February 6, 2023. He was congratulated by the Commission members.

Michael Feldewert, counsel in several cases that have been continued to the May 11, 2023 Commission docket, asked if May 11 would be a status conference or if the Commission would hear the cases on that date. After discussion, it was decided that the Commission would set the cases for a status conference on February 9, 2023. Mr. Feldewert agreed to contact all other parties involved to see if they will be available on that date.
