  - **Case 23580: Application of Wildearth Guardians to Consider the Proposed Amendments to the address Perfluoroalkyl and Polyfluoroalkyl Substances and their use in oil and gas extraction, 19.15.2, 19.15.16, 19.15.31, and 19.15.32 NMAC.**
  - **Case 24277: Application of Goodnight Midstream Permian, LLC to Amend Order No.R-7767 to exclude the San Andres Formation from the Eunice Monument Oil Pool Within the Eunice Monument South Unit Area, Lea County, New Mexico.**
  - **Case 24278: Application of Goodnight Midstream Permian, LLC to Amend Order No. R-7765, as amended, to exclude the San Andres formation from the Unitized Interval of the Eunice Monument South Unit, Lea County, New Mexico.**
  - **Case 23775: The following cases were referred to the Commission by Order No. R-23048 and concern competing Applications of Goodnight Midstream Permian, LLC (Goodnight) and Empire New Mexico LLC (Empire) concerning saltwater disposal wells and injection authority in, Lea County, New Mexico.**
    - **Division Cases 23614-23617:** Goodnight seeks orders authorizing injection of produced water for disposal into the San Andres formation between approximately 4,100 and 5,300 feet.
    - **Division Cases 24018-24027:** Empire seeks orders revoking Goodnight's existing permits to inject produced water into the San Andres formation. Case Nos. 24018, 24019, 24020, and 24025 involve Goodnight's four active wells that are located within the EMSU – the Andre Dawson SWD #1 (30-025-50634), the Ernie Banks SWD #1 (30-025-50633), the Sosa SWD #1(30-025-47947), and the Ryno SWD #1 (30-02543901), respectively. Case Nos. 24022, 24024, 24026, and 24027 involve Goodnight's four active disposal wells that are located within approximately one mile of the EMSU–the Pedro SWD #1 (30-025-50079), the Nolan Ryan SWD #1 (30-025-45349), the Ted SWD #1(30-025-44386), and the Yaz SWD #1 (30-025-46382), respectively. Case Nos. 24023 and 24021 involve Goodnight's permitted Verlander SWD #1 (30-02550632) and Rocket SWD #1 (30-025-pending), respectively, which are also located Order No. R-23048within approximately one mile of the EMSU. In Division Case No. 23775, Goodnight seeks authorization to increase the rate of injection into the Andre Dawson SWD #1 within the EMSU.

**Prior Cases Set for Hearing:**

**Case 23655: Application of the Joint Industry Technical Committee to Amend Order No. R-111-P, Lea and Eddie Counties, New Mexico.** Applicant in the above-styled cause seeks to amend Commission Order R-111-P, adopted in 1988 under Case 9316, to add anti-collision measures, to modify the well

casing and cementing requirements, to provide additional notification requirements to potash operators, to provide for subsidence monitoring, and to adopt other proposed changes for oil and gas development in the Known Potash Leasing Area located in Eddy and Lea Counties, New Mexico. This area presently consists of all or parts of:

Township 18 South, Range 30 East  
Township 19 South, Ranges 29 through 34 East  
Township 20 South, Ranges 29 through 34 East  
Township 21 South, Ranges 29 through 34 East  
Township 22 South, Ranges 28 through 34 East  
Township 23 South, Ranges 28 through 31 East  
Township 24 South, Ranges 29 through 31 East  
Township 25 South, Range 31 East

Said area extends approximately 50 miles east of Carlsbad, New Mexico and approximately 50 miles south of Maljamar, New Mexico.
