CONDITIONS OF SALE – INSTRUCTIONS

You must own at least one acre of land in the State of New Mexico and seedlings must be used for conservation purposes.

Minimum order for "One Season" containerized trees (10 cubic inch pot) is **49.** Order Multiples of 49 of a single species or package type (i.e., \$90/49 trees, \$180/98, \$270/147, \$360/196, etc.).

There is a \$5.00 handling fee per order. In addition, if you choose to have your order shipped there is an additional \$20.00 per lot shipping fee for each lot ordered (i.e. \$20.00/49 seedlings, \$40/98 seedlings, etc.) due to increasing UPS costs.

PAYMENT MUST ACCOMPANY YOUR ORDER. Make checks payable to NM FORESTRY DIVISION. Credit card purchases must be made online. PURCHASE orders are accepted from schools and local, state, and federal government agencies. <u>NO COD</u> ORDERS ACCEPTED.

All sales are final. Because it is impossible for us to monitor planting techniques and seedling care, the Forestry Division makes no guarantee of survival after shipment or delivery is made.

UPS shipments are made **Monday, Tuesday, and/or Wednesday** from September 16 – October 18, 2024. Your order will be shipped on one of those days.
