UPS Shipping Week

UPS shipments will be made Monday, Tuesday and/or Wednesday starting March 11, 2024, and ending April 22, 2024. You can choose your week, but not the day.

Santa Fe Pick-up Date

Thursdays and Fridays only from 8:30 am – 12:00 pm and 1:00 pm – 4:30 pm from March 14 through Friday April 26, 2024 (we will be closed Good Friday March 29).

<u>Alternate Choice</u> - Some species have limited numbers. Please choose an alternate in order of preference (i.e., Aspen (2) for 2nd choice, White fir (3) for 3rd choice, etc.). In the event we are sold out of your selection you will be sent an alternate choice. Alternate choices must be of the same pack type.

NM Forestry Division Spring 2024 Conservation Seedling Order Form CONDITIONS OF SALE – INSTRUCTIONS

You must own at least one acre of land in the State of New Mexico and seedlings must be used for conservation purposes.

Minimum order for bare root trees is **50.** You can split the order in bundles of 25 of a single species. For example: 1 bundle of Lilac and 1 bundle of Bur Oak = 50 seedlings (\$64/50 seedlings, \$9/675, \$128/100, \$160/125, \$192/150, etc.). Please indicate in the *alternate* column a 2nd choice, 3rd choice, etc. in the event we are sold out of your 1st choice. *Alternates* must be of the same pack type.

Minimum order for containerized seedlings in10 cubic inch tubes is **49**. Order Multiples of 49 of a single species or package type (i.e., \$90/49 trees, \$180/98, \$270/147, \$360/196, etc.).

Minimum order for containerized seedlings in 16-20 cubic inch tubes is **20.** Order Multiples of 20 of a single species (i.e., \$57/20 trees, \$114/40, \$171/60, \$228/80, etc.).

Minimum order for containerized seedlings in 40 cubic inch tubes is **20.** Order Multiples of 20 of a single species (i.e., \$90/20 trees, \$180/40, \$270/60, \$360/80, etc.).

There is a \$5.00 handling fee per order. In addition, if you choose to have your order shipped there is an additional \$20.00 per lot shipping fee for each lot ordered (i.e. \$20.00/49 or 20 seedings/\$40.00/98 or 40 seedlings, etc.) due to our UPS costs doubling in the past year.

PAYMENT MUST ACCOMPANY YOUR ORDER. Make checks payable to NM FORESTRY DIVISION. PURCHASE orders are accepted from schools and local, state, and federal government agencies. NO COD ORDERS ACCEPTED.

All sales are final. Because it is impossible for us to monitor planting techniques and seedling care, the Forestry Division makes no guarantee of survival after shipment or delivery is made.

UPS shipments are made **Monday, Tuesday and/or Wednesday** from March 11 – April 24, 2024. Your order will be shipped on one of those days. You should receive your order by Thursday of your chosen week. MAKE SURE THE WEEK YOU WANT YOUR ORDER SHIPPED IS WRITTEN ON THE ORDER FORM UNDER UPS SHIPPING WEEK ON OF THE ORDER FORM. THE deadline for purchasing for UPS shipments is April 19, 2024. UPS is independent of NM Forestry Division therefore we cannot guarantee condition of plants upon arrival.

Make sure your selected pick-up date is written on the order form under Santa Fe Pick-up Date. A reminder will be mailed to you with a map to the Tree House. Please write your selected pickup date on the order form. A reminder will be sent. The deadline for purchasing seedlings is April 19, 2024.
