The following are not reimbursable:

- responsibility for tort claims or compensation for injury costs;
- non suppression rehabilitation costs are the responsibility of the Jurisdictional Agency;
- non-expendable property purchases (are the responsibility of the Agency making the purchase); and
- support costs (*i.e.* office dispatchers, warehouse workers, etc.), unless they are charging to an emergency code assigned to the incident.

Fire Suppression Costs will be divided between agencies as described below: The costs on the Last Chance Fire will be shared by percentage of Agency Jurisdictional responsibility as per option C. above. Following are the percentages that will be used as provided by the Tudor Type 3 Team: USFS – Lincoln National Forest 22,558 Acres 42.3% BLM – Carlsbad Field Office 16,682 Acres 31.3% EMNRD – NM Forestry Division 14,102 Acres 26.4% % Acres Total 53,342 Acres 100.0% Federal Agencies will individually bill the EMNRD - NM Forestry Division for 26.4% of their costs. The EMNRD - NM Forestry Division will bill the US Forest Service for 73.6% of the Forestry Division's costs.

10. This Cost Share Agreement is our best judgment of Agencies cost responsibilities for this incident on the date/time shown. Future amendments to this Cost Share Agreement may be necessary, as conditions and fire spread change. This Cost Share Agreement can be negotiated in the field but only the State Forester has the authority to enter into a cost share agreement on behalf of the EMNRD, Forestry Division.
