

Urban Forest Council Scholarship Application



Purpose:

The New Mexico Urban Forest Council recognizes the need for skilled workers and continuing professional development in maintaining a sustainable healthy urban and community forestry. For this reason, we are offering scholarships to provide opportunities to participate in workforce development activities that will ultimately build local capacity to care for community and urban forests.

Eligibility:

Scholarships are open to all and will be awarded based on a competitive application process. Applications will be accepted year-round and will be reviewed periodically. Awards will be based on the availability of funds and a scoring evaluation performed by a panel of urban forestry professionals. Prioritization will be given to applicants who live or work within communities identified as disadvantaged using online vulnerability and environmental justice equity data tools (White House Climate and Economic Justice Screening Tool (CEJST), Environmental Protection Agency (EPA) Environmental Justice and Screening Mapping Tool (EJScreen), or the EPA EnviroAtlas Interactive Map).

This scholarship will cover conference registration fees, training fees, educational materials such as study guides or supplies, and examination fees. Travel costs will be covered for events in state, recipients will be responsible for out of state travel expenses.

The Urban Forest Council reserves the right to partially fund scholarships and applicants will be notified before any partial funding is approved.

Successful applicants will be required to provide a final report to the Urban Forest Council detailing activities undertaken and how these activities will contribute to the urban forest.

Scholarship Match Documentation Form

Match documentation is important to help document and justify funding for urban and community forestry education programs. If you are able to provide any match please complete the Match Documentation Form and submit along with copies of any receipts and time sheets

Examples of Qualifying Match Expenses:

- Gas for travel to/from training
- Mileage for travel to/from training
 - o .65/mile
- Food and lodging expenses during training (alcoholic beverages excluded)
- Salary/Wages time spent at training
 - Include copy of time sheet with pay rate given
- Volunteer time spent getting to/from and during conference
 - o Current volunteer in-kind rate is \$31.80/hour
