Good morning Larry,

All annual passes sold prior to our changes going into effect will be honored until their expiration date. Our Annual Camping Pass covers the base cost of developed camping, so regardless of what the cost of developed camping is set at, the pass will still cover that charge. The pass holder will still be responsible for paying utility fees. We are planning to move pass sales to match the calendar year. For 2025 we will be pro-rating our annual camping passes to allow individuals whose current passes expire mid-year to purchase a pass only for the remaining months of the year. After the initial year, in 2026 all passes will be based on calendar year. Please let me know if you have any further questions.
