


I did want to discuss the potential issue of having my son as a YCC member in a few years and how we should handle that situation. I thought you were aware that Aldo has had all 10th graders do YCC (since 2020 or 2021 I think, it was a decision Wayne made to build structure into our internship program). Is that okay? The students don't really "interview" anymore, they just express interest in a crew and they usually get on that crew or their backup choice. We do fill in positions with 11th and 12th graders after all of the 10th graders have a spot. I'm not entirely sure how this differs from how things used to be done but it is my understanding that we've been doing it this way for a few years.

I have also had a few YCC trainers ask about having 2 crew leaders. Is that okay? It sounds like it's been done in the past but only in summer and I wasn't sure if there was a rule for that. What about paying 2 trainers for a crew? Is that allowed?


