A RESOLUTION TO SUPPORT THE DESIGNATION OF 1.9 MILES OF THE MULTI USE PATH AS PART OF THE NEW MEXICO RIO GRANDE TRAIL.

The City Council is informed that:

WHEREAS, on April 2, 2015, legislation was signed into law establishing the Rio Grande Trail Commission; and

WHEREAS, the mission of the Rio Grande Trail Commission is to plan, design, and construct a recreation trail called the "Rio Grande Trail" (RGT) that runs parallel to the Rio Grande River and extends the length of New Mexico from Texas to Colorado; and

WHEREAS, the RGT will traverse a diversity of majestic New Mexico landmarks and natural and cultural landscapes including six state parks, two national wildlife refuges, and three national monuments and will also travel through multiple governmental jurisdictions including at least ten cities with populations of more than 5,000, and 22 counties; and

WHEREAS, it will provide an excellent potential for economic development and recreation for the state of New Mexico and communities and small businesses along the path; and

WHEREAS, in 2016 over five million people visited New Mexico state parks and outdoor recreation contributed 3.8 billion dollars of annual economic impact throughout New Mexico; and

WHEREAS, Elephant Butte enjoys a recreation trail along the Elephant Butte Lake and the City of Elephant Butte; and

WHEREAS, the Multi Use Trail is a 1.9 mile paved and landscaped path on the

West bank of Elephant Butte Lake from Elephant Butte Boulevard and d Country Club Road to Rock Canyon Blvd. and Calle Del Contento. The Multi Use Trail Trail provides panoramic views of the lake and the surrounding mountain vistas. The Multi Use Trail can be easily be utilized by Wheel chairs, walkers, bicycles, stroller's roller-skates/blades or simply walking or jogging.


THAT the City supports the designation of the 1.9 -mile Multi Use Trail, as part of the New Mexico RGT.


