The purpose of the Rio Grande Trail Commission (RGTC) meeting is to advance the development of the Rio Grande Trail (RGT), a statewide route planned to extend from Colorado to Texas. Agenda items include reports from the four subcommittees—Alignment, Legislative, Tribal, and Non-Profit—as well as discussion on designating additional trail segments.
