**Re: Rocky Mountain Mine Financial Assurance Reduction
Request for Modification of Permit No. RA004RE**

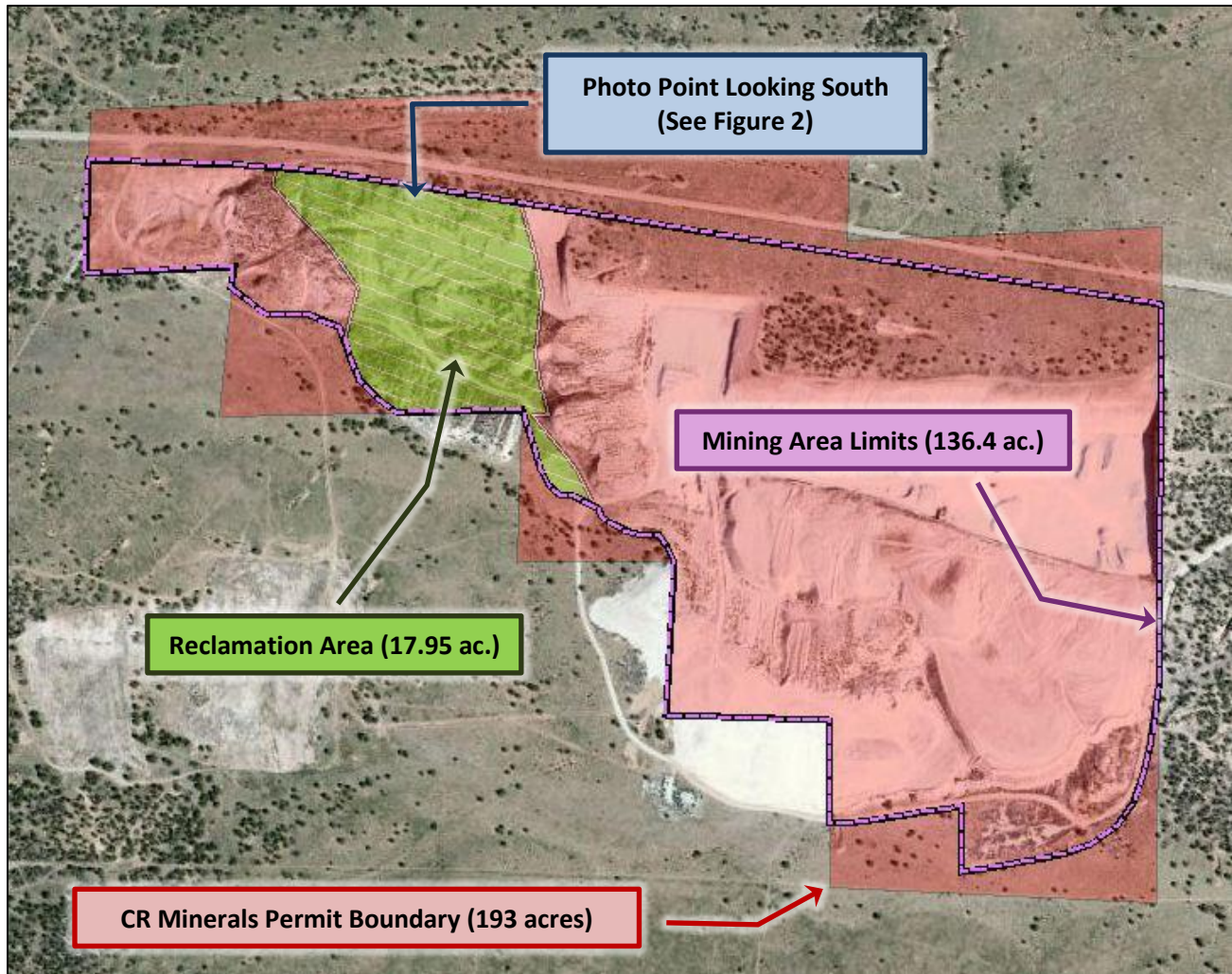


Figure 1. Rocky Mountain Mine mining area limits and reclamation area.

CR Minerals Company, LLC (CR Minerals) requests a partial release of financial assurance pursuant to 19.10.12.1210 NMAC and a modification of Mining Act Permit No. RA004RE to reduce the amount of financial assurance required for implementation of the closeout plan. CR Minerals specifically requests that the financial assurance be reduced for 17.95 acres of earthwork completed in 2012 within the mining area limits (Figure 1).

DESCRIPTION OF WORK COMPLETED: Grading consisted of smoothing and sloping the top surface of overburden stockpiles across 20.7 acres, of which 17.95 acres were within the mining area limits (Figure 1), into one continuous smooth surface that evenly drains south with slopes $\leq 5H$ to $1V$ ($\leq 11^\circ$) (Figure 2). The earthwork was initiated in July and was completed in August of 2012. There are no perennial, intermittent, or ephemeral drainages south of the completed reclamation area, and the reclamation area does not drain directly into a defined channel or erosion feature. Although not illustrated in Figure 1, there is one area south of the Reclamation Area on BLM land that was also reclaimed. This area is not within the mining area limits and was not included in the total area used to calculate the requested partial release of financial assurance.

None of the 17.95 graded acres of the above described reclamation area (Figure 2) has been seeded. As a result, no partial release of financial assurance for seeding will be requested in 2012.

PROPOSAL TO MODIFY FINANCIAL ASSURANCE: The current value of the financial assurance is \$312,532. CR Minerals requests that the financial assurance be reduced by a total of \$37,838 to account for reclamation work completed to date on the above referenced reclamation area within the mining area limits. The details of the existing financial assurance and the requested release are detailed below in Table 1 (Also see Attachment 1). Attachment 1 provides comprehensive details of proposed corrections to the existing financial assurance using the NM MMD Microsoft Excel reclamation estimate cost model. The following assumptions were used in the model:

- Area graded within mining area limits in 2012 = 17.95 ac.
- Area seeded within mining area limits in 2012 = 0.0 ac.

The following factors were changed in the MS Excel model:

- “Grading” Tab: Acreage reduced from 117.9 acres to 99.95 acres
[117.9 acres left ungraded in mining area limits – 17.95 acres graded in 2012 = 99.95 acres]
- “Reveg” Tab: No change from 2011.

The amounts shown above reflect the current financial assurance cost estimate to complete the specific reclamation work that has been completed in 2012, as well as the remaining cost of implementing the



closeout plan. The third column of Table 1 represents the portion of financial assurance CR Minerals requests to be released at this time. NM Gross receipts taxes are not included in these amounts.

PARTIAL FINANCIAL ASSURANCE RELEASE APPLICATION DETAILS: This application includes all the information required by the NM Mining Act under 19.10.12.1210 NMAC for a request to release financial assurance. Attachments are provided that contain the following information:

- **Attachment 1 – MS Excel Cost Model:** Revised MMD Microsoft Excel reclamation cost model for Permit No. RA004RE.
- **Attachment 2 – Public Notice Documentation:** The list of individuals that CR Minerals provided the public notice to via certified mail is provided in this attachment with an example copy of the notice letter. The list includes landowners within ½ mile of the property, state and federal agencies, local municipalities, and interested parties. Also, included in this attachment are affidavits and/or tear sheets documenting that the public notice for this application was published in the Rio Grande Sun newspaper in Española, NM on October 11, 2012. The list of public areas where the notice was posted is also provided. These notices were provided in accordance with 19.10.12.1210 A (3), 19.10.902, and 19.10.903 NMAC.

The estimate of total remaining closure/closeout work at the Rocky Mountain Mine required for financial assurance is \$274,694.

CR Minerals looks forward to the Director scheduling the required inspection of the closeout measures completed in relation to this application for partial financial release.

An overview of the current CR Minerals financial assurance and the instrument by which it has been implemented is provided in the CR Minerals Mining Act Permit No. RA004RE. Financial assurance for the closure/closeout of the Rocky Mountain Mine is in place in the form of a formal Letter of Credit amendment issued by Wells Fargo Bank (\$312,532 as of March 9, 2012).

CR Minerals requests that the NM MMD approve the partial release of financial assurance in the amount defined in Table 1.

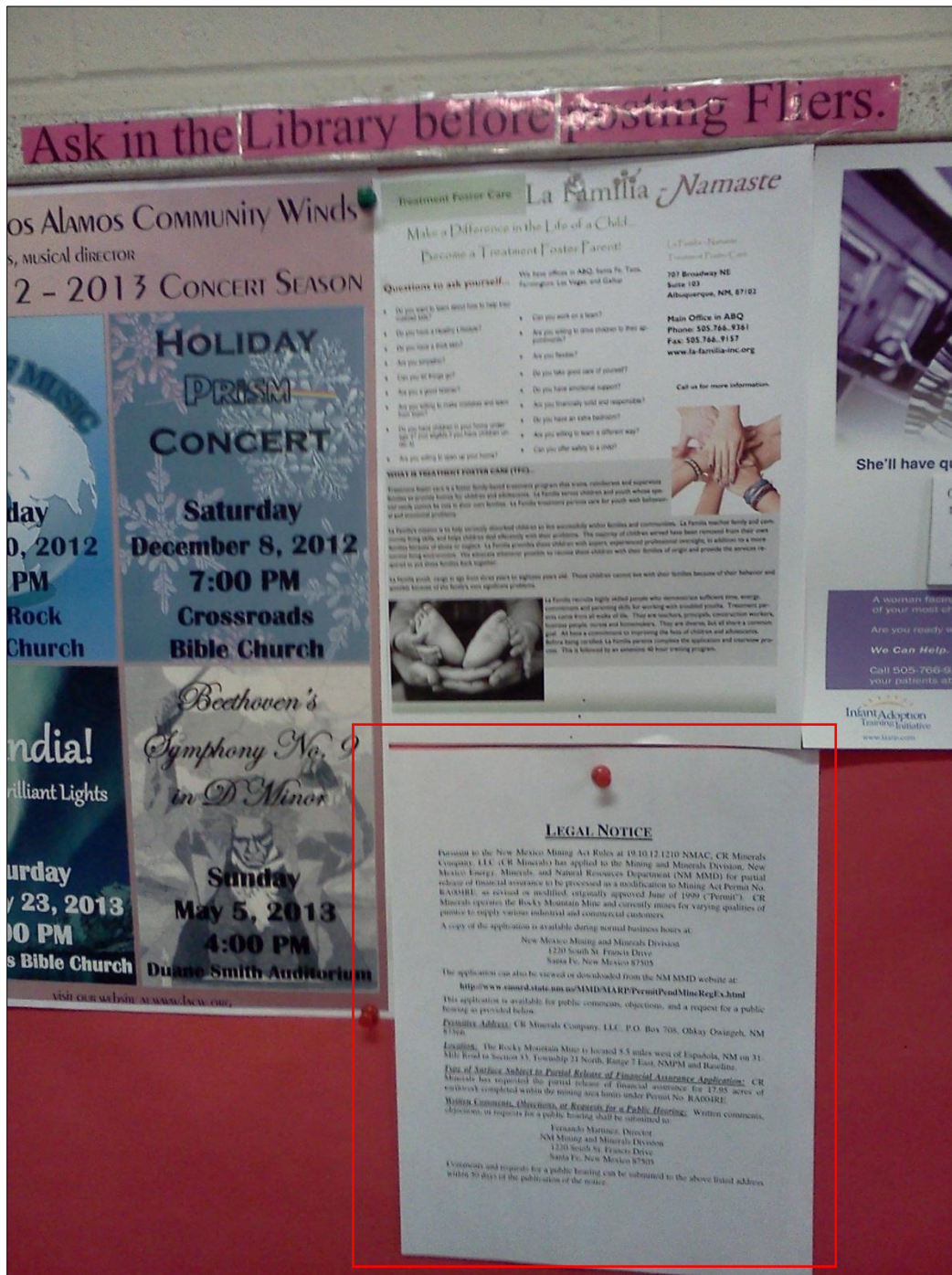

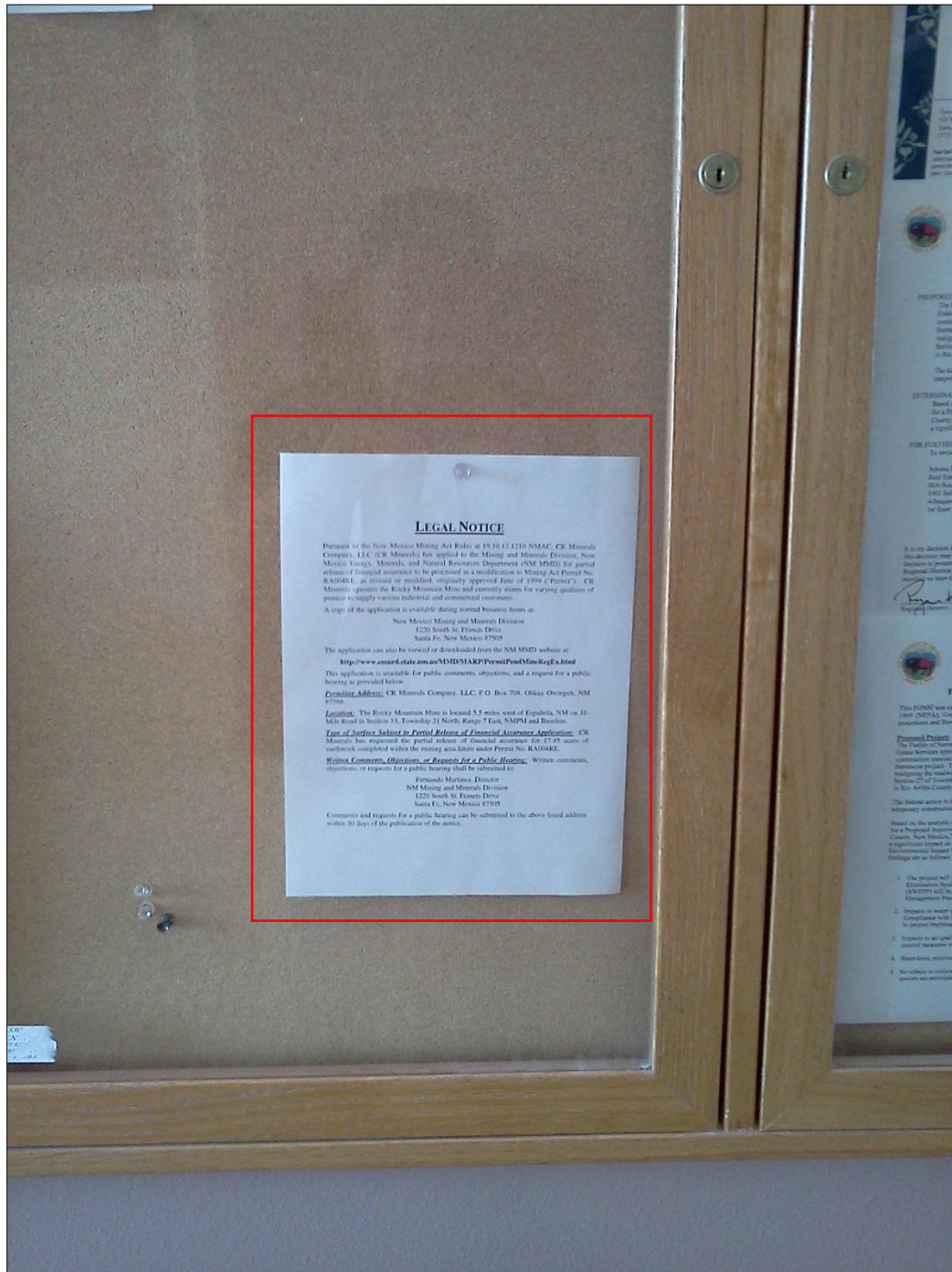
